

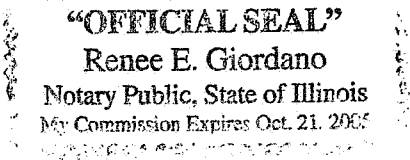

1. Please describe the major features of the project:

2414 South Oakley Ave. The scope of the work includes removal of existing decorative fencing and parkway excavation, and replacing the parkway area with brick pavers. This work is in addition to work completed on the Oakley Ave/ Blue Island Ave-24th Street JOC Project.
