



Four pedestrian underpasses in Lincoln Park require immediate concrete and stone repairs. The scope of work includes structural repairs to the underside of the deck, replacing reinforcement steel and concrete repairs to the pedestrian underpasses. The scope of work increased due to the unanticipated full depth concrete repairs and temporary shoring towers installation.

2. Please explain why this project could not be bid using the city's traditional bid process and the need to use JOC Procurement system.

The proposed additional full depth concrete repairs and installation of shoring towers require specialized personnel and equipment. The work can not be performed by City Forces and is not covered by an existing term agreements.
