#### **KEY TAKEAWAYS**

Suzanne Carlberg-Racich gave a presentation on harm reduction policy recommendations addressing the opioid epidemic in Chicago. These recommendations included using people-first language in all City communications and creating overdose prevention sites.

An important theme for policy is to ensure equitable and affordable healthcare services to address pharmacy desserts and increase school-based health services. Schools and community hubs are places that families and residents regularly go to, so providing services there would reach more community members.

Another recurring theme for ensuring equitable healthcare services is to increase the number of Black and Brown healthcare professionals. Policy ideas included funding and creating programs that will help Black and Brown youth and emerging adults enter the healthcare industry.

#### **N**otes

- Romina Castillo facilitated the meeting. She also shared a communications update. Based
  on feedback from the public, the City of Chicago is working on making the language in
  communications specifically the guiding questions for each pillar clearer to make them
  more accessible.
- Wesley Epplin introduced Suzanne Carlberg-Racich, an associate professor at the School of Public Health at DePaul University, who gave a presentation on harm reduction policy recommendations.
  - Harm reduction is recognizing any and all healthy options someone can take.
  - Reducing stigma and other agents of harm are important for harm reduction. A
    policy recommendation included adopting and promoting person-first language in all
    city communication.
- Epplin shared that the goals of the meeting are to brainstorm 3-5 policies per objective for the pillar's first two guiding questions.
  - Epplin said that a good policy identifies the policy lever and includes a measurable action.
  - City policy levers are the actions the City can do. They include funding and direct provision, rules and regulations, research and exploration, and information and support.
- Each breakout group was given access to a working document on Google Docs, which listed
  each objective for the guiding question the group was working on. It listed innovative policies
  from other cities and relevant policies from past City plans. It also listed policies
  brainstormed in previous discussions. It also included questions for team members to
  consider and answer for each objective:
  - O Which policies resonate with you?
  - How can we use the policy toolkit to improve or add to these policies? What can we keep, delete, edit, or refine to make more Chicago-centric?
  - o What is missing from this list?
- Breakout Group 1 discussed policy ideas for Guiding Question #1: How can we ensure equitable and affordable healthcare services for all Chicagoans?
  - Objective 1: Ensure access to affordable high-quality physical and behavioral health services. Policy ideas included:
    - Improving Medicaid reimbursements for behavioral and oral health.
    - Passing HB4437 for Medicaid coverage for immigrant adults ages 19-64.
    - Addressing drugstore pharmacy deserts by potentially funding a mobile pharmacy.



- Objective 2: Increase accessibility, funding, and quality of community health resources. Policy ideas included:
  - Using community hubs and schools to provide services.
  - Creating a program to make Community Health Worker training and certification more available and affordable.
- Brianna Lawrence said that one suggestion that came up in a community meeting
  was providing daily bus routes that have stops at local schools and community
  healthcare providers. Katelyn Johnson shared another suggestion from a community
  meeting about covering the gap in Medicaid prescription coverage.
- The group did not have time to address Objective 3 (Make physical and mental health trauma-informed and culturally responsive) and Objective 4 (Support Black and Brown Chicagoans' health career pursuits and successes).
- Breakout Group 2 discussed policy ideas for Guiding Question #2: How can we ensure
  equitable accessibility and safe freedom of movement with opportunities that promote
  optimal health and well-being for all Chicagoans? They also were only able to brainstorm
  policy ideas for the first two objectives of this guiding question.
- After the breakout sessions, the team reconvened. They did not share ideas and discussions
  from their breakout sessions. The next meetings will be similar to this one. They asked for
  feedback about the policy breakout session structure. Victoria Barrett said that she
  appreciated having speakers give presentations.
