The Department of Water Management Bureau of Engineering Services is requesting an emergency contract for Sewer Televising Program Services. This emergency request is required due to the early termination of the term agreement between the City of Chicago Department of Water Management and Municipal Sewer Services. Also, after ongoing discussions between DPS & DWM, it was decided that there should be two emergency requests, one for our North area and one for our Central area. Additionally, because this emergency is only for \$250,000.00, there may be a need for additionally emergencies depending on award of a new contract.

We have solicited quotes from seven vendors who provide the equivalent or like services. However, only two of the seven vendors responded to our request. Therefore, we are recommending that award be made to National Power Roding Corporation, the lowest quote supplied. Attached is the DPS checklist, requisitions 38229 & 38230 and quotations from National Power Rodding Corporation and Brunt Brothers Transfer.
