**Under Illinois law, to qualify for an appointment as Alderman, you must meet the below criteria:**

- 1) You must be registered to vote in the City of Chicago;
- 2) At the time you are sworn in as Alderman, you must have resided in the ward for at least one year prior to taking office;
- 3) You must not be in arrears in the payment of taxes or other indebtedness to the City of Chicago;
- 4) You must not have been convicted in any court located in the United States of any infamous crime, bribery, perjury, or other felony;
- 5) At the time you are sworn in, you shall not hold any other office in the City of Chicago, nor hold any civil service office under federal, state, or local government unless granted leave of absence. National Guard, notary public, and honorary offices without compensation are exceptions to this requirement.

**To be considered, completed application forms must include the following supplemental materials:**

- 1) A cover letter to Mayor Johnson expressing your interest in being considered for the appointment;
- 2) A resume that includes details about your prior work experience and your educational background; and
- 3) At least three letters of recommendation from community leaders, business leaders, or residents of the 27<sup>th</sup> Ward.
