Criminal Prosecutions Bureau, Felony Review Unit (FRU), November 2024 - Present

- The unit operates 24/7, 365 days a year. It has 12-hour shifts: 5:30 AM—5:30 PM, noon to midnight, and 5:30 PM—5:30 AM (three days on, three days off).
- Assigned to a team of six line ASAs and two trial supervisors responsible for reviewing all felony charges that law enforcement agencies within Cook County intend to pursue.
- Cases are reviewed either over the phone or in person at law enforcement partner headquarters or in the field, such as police stations, crime scenes, hospitals, homes, and more.
- Reviewed all different types of felony charges, including Hate Crimes, First Degree Murder, Attempt Murder,
 Officer-Involved Shootings, Armed Robbery, Criminal Sexual Assault, Fraud, Vehicular Hijacking, Child
 Abuse, Domestic Battery, DUI, Animal Cruelty, Failure to Register as a Sex Offender, and other criminal
 charges.

Special Prosecutions Bureau, Domestic Violence (DV) Division, June 2024 - November 2024

- One of two ASAs assigned to a branch DV courtroom, handling a vertical prosecution caseload of ~800. All cases originate out of Chicago and are partner abuse, same-sex domestic violence, sex crimes, child abuse, and other domestic-related crimes of violence.
- Responsibilities include first chairing jury and bench trials, preparing daily court calls, drafting and arguing motions, coordinating with victim-witness specialists, training and overseeing clerks and 711 Limited License Law Clerks, and actively communicating with victims of all backgrounds who speak many different languages.
- During time assigned to the Domestic Violence Division, first chaired five jury trials to verdict.
- Member of the Antisemitic Hate Crime Task Force.

Criminal Prosecutions Bureau, First Municipal Division, May 2023 – May 2024

- First Municipal record-setting misdemeanor jury trial first chair, trying 20 cases to verdict. Cumulatively, questioned ~560 potential jurors ranging in life experience from a former congresswoman to a retired judge to convicted felons and argued countless motions to reconsider, for a new trial, and to quash evidence.
- Lead prosecutor of one of Chicago's four misdemeanor branch courts after having spent time working in each branch court.
- Trained five new ASAs on how to run a courtroom and court call and effectively manage a caseload of many hundreds. Tasked with reviewing charges relating to protests of various backgrounds and ultimately recommending whether to prosecute.
- Regularly communicated with victims; defense attorneys; Chicago Department of Aviation Commissioners; Chicago Fire Department Officials; City of Chicago Officials—both elected and career; and law enforcement officials from the Chicago Police Department, Illinois State Troopers, Illinois Department of Revenue Investigators, University of Illinois Chicago Police, University of Chicago Police, Northeastern Illinois University Police, Metra Police, Amtrak Police.
