

- The 2023 Budget Recommendation appropriates **\$1,943.4 million** to CPD, an increase of \$64.3 million, or 3.4%, from FY22 (revised).
- The appropriation categories driving the FY23 increase are Personnel, Contractual Services, & Financial Purposes as Specified, which are increasing by \$17.3 million, \$16.5 million, and \$28.6 million, respectively, from the revised FY22 budget.
- CPD receives a majority of its funding—88%—from the Corp Fund.
- The proposed FY23 Budget appropriates **14,137 positions** to CPD, which is 35 positions more than FY22.
- With 12,330 Active employees as of Oct 2022, COFA estimates CPD's vacancy rate to be **12.6%**.
- CPD is appropriated **\$106.9 million for overtime** in FY23, which is a decrease of \$2.95 million, or **(2.7%)**, from FY22's revised budget.



Historical Overview of CPD Overtime Spend


