Pursuant to Chapter 4-60-040(h) of the City of Chicago Municipal Code ("Municipal Code"), the City of Chicago Local Liquor Control Commission (LLCC) and the above named Licensee have agreed to the issuance of the above-referenced Licenses under the following conditions:

1. Licensee agrees that the service of alcoholic beverages, shall at all times be incidental to the primary business activities of offering the service of food.
2. Licensee shall comply with all applicable provisions of the Chicago Noise and Vibration Control Ordinance.
3. Licensee shall immediately report any criminal activity viewed in and around the Premises to the Chicago Police Department.
4. Licensee agrees that all staff responsible for alcohol beverage service shall be BASSET certified.
5. Licensee will display a sign in a conspicuous location near the front door inside the Premises that reads, "Please Respect Our Neighbors, Please Exit Quietly and Do Not Loiter."
6. Licensee shall regularly monitor the exterior area in and around the Premises during regular business hours in order to address and abate any complaints relating to noise, loitering, parking or littering, arising from the conduct of Licensee's patrons.
7. Licensee shall comply with the Chicago Clean Indoor Air Ordinance and the Smoke Free Illinois Act.







The conditions of these Licenses issued pursuant to this Plan of Operation shall apply to the business address and Licensee and to all officers, managers, partners, and direct or indirect owners of the licensed entity. The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the Licenses. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this statement.


