**LIQUOR LICENSE PLAN OF OPERATION**

Per Chapter 4-60-040(h), of the City of Chicago Municipal Code, the City of Chicago Department of Business Affairs/Local liquor Control Commission (DBA) has authorized the issuance of a Consumption on Premises/Incidental Activity liquor license to the above-named business entity and business location under the following conditions:

1. Licensee will operate a full service, sit down restaurant. The primary business activity will be the sale and service of food. Alcohol sales and consumption will only be incidental to the food service. Licensee further agrees to provide an updated copy of the restaurant menu prior to execution of this plan of operation. At no time will the business be operated as a tavern/nightclub.
2. Business hours will be as follows: Monday through Friday opening no earlier than 11:00 a.m. and closing no later than 1:00 a.m. Saturday opening at 10:00 a.m. for brunch and closing no later than 2:00 a.m., and Sunday opening at 10:00 a.m. for brunch and closing at 10:00 p.m. On Sunday, no liquor will be sold or consumed prior to 10:00 a.m.
3. The licensee agrees to not apply for a Public Place of Amusement license and further agrees to not have any live entertainment at the premises.
4. The licensee agrees to not install any DJ equipment, dance floor or stage on the premises.
5. The licensee agrees to not apply for a Late Hour Liquor license.

6. The licensee will monitor the area around the business and the nearby area from open to close and keep it clean, free of garbage and debris.
7. Garbage will be picked up by a private waste management company on a timely basis insuring no over flow of garbage from the business.
8. The licensee agrees to not expand the licensed premises without applying for an expanded establishment liquor license.
9. Licensee agrees to attend local CAPS meetings on a regular basis.
10. Licensee has met with the local alderman for the Ward where the business is located to discuss the background of the business.
11. Licensee agrees to meet with the appropriate police commander and community residents to discuss any problematic concerns that may arise regarding the operation of the business.
12. Licensee agrees that if Licensee later applies for and is granted a sidewalk café license for the premises, that the provisions of this plan of operation shall also apply and remain enforceable regarding such sidewalk café license.

The conditions of this liquor license are legally binding and may be enforced by City of Chicago enforcement authorities under MCC 4-60-040(h). All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a suspension or revocation of all business licenses issued to the licensee. Violations of the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the liquor license shall apply to the business address and licensee and to all officers, managers, members, partners and direct or indirect owners of the entity of which is licensed. The sale of the business to other persons purchasing the stock or membership units of the licensed entity shall be subject to the same conditions set forth in this plan of operation.


It shall be the duty of every person conducting, engaging in, operating, carrying on or managing the above-mentioned business entity to post this Liquor License Plan of Operation next to the Liquor License certificate in a conspicuous place at the business address.


