Pursuant to the City of Chicago Municipal Code Section 4-60-040 (h), the City of Chicago Department of Business Affairs and Consumer Protection (BACP) / Local Liquor Control Commission of the City of Chicago and the above-named Licensee have agreed to the issuance of a Consumption on Premises - Incidental Activity Liquor License and Retail Food Establishment licenses under the following conditions:

- Licensee shall operate as a restaurant where the primary business activity will be the sale and service
 of food and where the sale of alcoholic beverages will only be incidental to the food service. The
 Licensee shall not operate in a manner where the sale of alcoholic beverages is the primary business
 activity.
- Licensee agrees that in the event the Local Liquor Control Commission receives a complaint, the
 Licensee shall cooperate fully with any investigation, including but not limited to, submitting any
 records requested by the Local Liquor Control Commission. The Licensee shall, upon request of the
 Local Liquor Control Commission, produce any records the Local Liquor Control Commission has
 requested within thirty (30) days of such request.

3. Hours of Operation:

- a. Licensee shall cease all restaurant operations, including food service, not later than 10:00 pm. all days.
- b. Licensee will cease the sale of alcoholic beverages at 10:00 pm. on Sunday through Thursday, and at 10:00 pm. on Friday and Saturday.

- c. Licensee shall close the restaurant not later than 10:30 pm. all days.
- Licensee agrees that it will not, at any time, apply for a City of Chicago Late Hour Liquor License.
- e. During all hours that the business is open to the public, the kitchen is to remain open and Licensee shall offer food preparation and service to its patrons.
- 4. Licensee shall regularly monitor the exterior area around the premises during all of its business hours in order to address and abate noise, loitering and littering complaints about Licensee's patrons or employees.
- All restaurant staff will be BASSET or TIPS certified and will be trained with respect to the detection
 of fraudulent identification. All restaurant staff will be trained to identify intoxicated patrons and
 will take pro-active steps to prevent the intoxication of patrons.
- 6. Trash shall be collected regularly. Waste products will be bagged before being placed in dumpsters. Recycling will be separated and kept in an orderly fashion. Licensee will regularly clean the area around the dumpster to abate vermin. Licensee shall maintain sufficient trash containers to accommodate any additional waste generated. The Licensee shall ensure that all trash containers shall be locked and secured at all times.
- 7. Licensee will enforce all applicable City and State non-smoking laws as they relate to both the interior and the exterior of the Premises.
- 8. Licensee shall take steps to avoid loitering by patrons. Should there be patrons that refuse to stop loitering and become problematic, the incident shall be documented in an Incident Log and the Chicago Police Department shall be contacted.
- 9. Licensee will display a sign in a conspicuous location which reads, "Please Respect Our Neighbors, Please Exit Quietly and Do Not Loiter."
- 10. The terms and conditions of this Plan of Operation shall not be altered or amended prior to six months after the date of issuance of the amended Consumption on Premises Incidental Activity Liquor License. After that date, representatives from the Department of Business Affairs and Consumer Protection, the local Alderman's office and the Licensee may meet to discuss amendments to this Plan of Operation.

The conditions of this liquor license are legally binding and may be enforced by City of Chicago enforcement authorities under Section 4-60-040(h) of the City of Chicago Municipal Code. All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violations of the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the business licenses issued pursuant to this Plan of Operation shall apply to the business address and Licensee and to all officers, managers, members, partners and direct or indirect owners of the

entity of which is licensed. The sale of the Licensee to other persons purchasing the stock of the licensed entity shall be subject to the same conditions set forth in this Plan of Operation. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this statement.

It shall be the duty of every person conducting, engaging in, operating, carrying on or managing the above-mentioned business entity to post this Liquor License Plan of Operation next to the Liquor License certificate in a conspicuous place at the business address.
