Pursuant to Chapter 4-60-040(h) of the City of Chicago Municipal Code ("Municipal Code"), the City of Chicago Local Liquor Control Commission (LLCC) and the above named Licensee have agreed to the issuance of the above-referenced Licenses under the following conditions:

- 1. The Licensee will not allow patrons to take liquor, sold for consumption on premise, from the licensed premises (including boats). The licensee will take all the necessary steps to ensure that patrons do not take liquor sold for on premise consumption off of the licensed premises.
- 2. Licensee shall immediately notify the Police of any illegal activity viewed in and around the Premises.
- 3. All bar and wait staff will be BASSET or TIPS certified, and will be trained with respect to the detection of fraudulent identification. All bartenders and wait staff will be trained to identify intoxicated patrons and will take pro-active steps to prevent the intoxication of patrons.

The conditions of these Licenses issued pursuant to this Plan of Operation are legally binding and may be enforced by the City of Chicago enforcement authorities. All other conditions of the Licenses are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violation of the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the licenses.

The conditions of these Licenses issued pursuant to this Plan of Operation shall apply to the business address and Licensee and to all officers, managers, partners, and direct or indirect owners of the licensed entity. The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the Licenses. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this statement.
