Pursuant to the City of Chicago Municipal Code Section 4-60-040 (h), the City of Chicago Department of Business Affairs and Consumer Protection (BACP) and the above-named Licensee have agreed to the issuance of an Outdoor Patio liquor license, under the following conditions:

- 1. EOsco Drug #3376 shall have an operational security system in place to protect to monitor the outdoor premises as follows:
 - a. E Security footage shall be maintained for a minimum of 30 days indexed by time and date.
 - b. EAll recordings shall be stored in a secured manner and copies of the video surveillance shall be made available to the City of Chicago Police Department upon request.
 - c. E The images recorded by the cameras shall be capable of being viewed through use of electronic file transfer and other digital media.
- 2. EOutdoor area will contain adequate lighting to ensure visibility and customer safety
- 3. EAny illegal or suspicious activity on our premises or in the surrounding area will be immediately reported to law enforcement and recorded in our incident log, as required under Section 4-60-161 of the Chicago Municipal Code.
- 4. EManagement shall immediately address any public nuisance issues which adversely impact the health, safety, and welfare of the community.

- 5. Osco Drug #3376 shall comply with the Chicago Noise and Vibration Control Ordinance, Chapter 8-32 of the Chicago Municipal Code.
- 6. A sign will be displayed in the outdoor location which reads: "Please Respect Our Neighbors, Please Exit Quietly and Do Not Loiter." Additionally, signage explicitly stating "Only patrons above the age of 21 may consume alcohol on the premises" will be displayed on the door leading to the outdoor patio area.
- 7. _ Licensee shall take steps to prevent and prohibit any patron from leaving the premises with any alcoholic liquor, except in a package properly sealed, bagged and receipted pursuant to Section 5/6-33 of the Liquor Control Act of 1934.
- 8. Licensee will monitor the outside premises to avoid vagrancy and loitering.
- 9. Licensee will control the accumulation of litter from its customers and other individuals by maintaining a routine sweep of litter outside of the establishment. Trash containers will be kept within proximity of the building.
- 10. All Licensee bar staff will be BASSET certified in accordance to the State of Illinois regulations. Staff will be trained in how to spot false identification, identify intoxicated patrons, and take proactive steps to prevent incidents.
- 11. Licensee will be compliant with all local smoking and e-cigarette regulations. There will be absolutely no smoking on the premises or within 15 feet of any entryway.
- 12. Licensee agrees that there will be no outdoor music played on the Outdoor Patio.
- 13. Loss Prevention staff will attend CAPS (Community Alternative Policing Strategy) meetings, as well as Hospitality meetings, and any other similar CPD-sponsored meetings. As well as communicate with CPD district business liaison to improve awareness of community concerns within the neighborhood.

The conditions of the Outdoor Patio liquor license issued pursuant to this agreed plan of operation are legally binding and may be enforced by the City of Chicago enforcement authorities under MCC 4-60-040. All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violation of the above stated conditions of the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the Outdoor Patio liquor license issued pursuant to this plan of operation shall apply to the business address and license and to all officers, managers, partners, and direct or indirect owners of the licensed entity. The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the license. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this pan of operation.

It shall be the duty of every person conducting, engaging in, maintaining, operating, carrying on or managing the above-mentioned business entity to post this plan of operation next to the liquor license in a conspicuous place at the business address.
