LIQUOR LICENSE PLAN OF OPERATION

The City of Chicago Department of Business Affairs & Consumer Protection/Local Liquor Control Commission and the above named licensee, in partial settlement of case 19-LR-0017, have agreed to the following license conditions concerning the operation of the business:

1. Licensee shall operate as bar with a retail liquor license. The primary business activity will be the sale and service of alcohol sales and consumption on the premises.
2. No licensee, employee, barkeeper or agent of the Licensee shall solicit, induce or request any patron of the licensed establishment to purchase any alcoholic or nonalcoholic beverage for him or herself or any other employee of the licensed establishment.
3. Licensee shall ensure that no employee, agent, entertainer, or patron of the licensed establishment engages in any conduct which exposes to public view: (1) his or her genitals, pubic hair, buttocks, perineum and anal region or pubic hair region; or (2) any device, costume or covering which gives the appearance of or simulates the genitals, pubic hair, buttocks, perineum, anal region or pubic hair region; or (3) any portion of the female breast at or below the areola thereof. For purposes of this provision, any of the items described herein shall be considered exposed to public view if it is uncovered or is less than completely and opaquely covered.
4. Licensee shall ensure that no employee, agent or patron of the licensed establishment engages in conduct which is designed primarily to appeal to the prurient interests of the employees, agents or patrons by engaging in explicit simulation of sexual activities, including, but not limited to:
 - a. Lap dances or other erotic dances where a dancer, even if fully clothed, engages in non-penetrative sexual contact with another person;
 - b. Acts of human masturbation, sexual intercourse or sodomy;

- c. Fondling or other erotic touching of human genitals, pubic region, buttock or female breast.
- d. Licensee shall not operate as an adult use without first having properly registered and received certification of approved registration for adult use.

The conditions of this Plan of Operation are legally binding and may be enforced by City of Chicago enforcement authorities under the City of Chicago Municipal Code §4-60-040(h). All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions, unless otherwise agreed to, may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violations of the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of this Plan of Operation shall apply to the business address and Licensee and to all officers, managers, partners and direct or indirect owners of the entity of which is licensed. The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the license. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this Plan of Operation.


