LIQUOR LICENSE PLAN OF OPERATION

Licensee: NB, Inc. d/b/a Nouveau Bistro
Premises: 5301-5305 W. Belmont Avenue, Chicago, Illinois 60641

Pursuant to the City of Chicago Municipal Code Section 4-60-040(h), the City of Chicago Department of Business Affairs and Consumer Protection/Local Liquor Control Commission (BACP/LLCC) and the above named Licensee have agreed to the issuance of a Consumption on Premises – Incidental Activity liquor license under the following conditions:

1. Pursuant to the representations made by Licensee, the business shall operate as a restaurant where the primary business activity will be the sale and service of food and where alcohol sales and consumption will only be incidental to the food service. At no time will the business be operated in a manner where alcohol sales are the primary activity.
2. During all hours that the business is open to the public, Licensee shall offer food preparation and service to its patrons.
3. Licensee agrees that in the event that the BACP/LLCC receives a complaint or other information that the business is not being operated as a restaurant, but in a manner where alcohol sales are the primary activity, Licensee shall fully cooperate with any investigation and submit any records requested by the BACP/LLCC.
4. Licensee agrees that if an investigation by the BACP/LLCC reveals that alcohol sales are the primary activity of the business, Licensee along with counsel shall meet with the BACP/LLCC within 20 days of a request to meet. At the meeting Licensee shall provide information to the BACP/LLCC that demonstrates that Licensee is not selling alcohol as its primary business activity. If Licensee does not provide sufficient information to establish that alcohol sales are not the primary activity of the business, Licensee shall be subject to an immediate Cease and Desist order.
5. Licensee agrees and acknowledges that any violation of paragraphs 1 through 4 may result in revocation of all licenses at the location.

6. Licensee will enforce all applicable City and State non-smoking laws as they relate to both the interior and the exterior of the premises.
7. Licensee agrees that all servers of alcoholic beverages shall undergo and be certified in alcohol server training via a BASSET or TIPS program. Licensee will keep each server's certification on the premises and will provide each server's certification upon request.
8. Licensee will announce "Last Call" for alcoholic beverage sales and service at least 30 minutes prior to the close of business.
9. Licensee agrees to not install any dance floor or stage on the premises. Licensee will ensure that any music played on the premises conforms strictly to all relevant City of Chicago ordinances, including sound and other environmental provisions.
10. The Licensee shall not allow any amusement activity, as defined by Section 4-156-010 of the Municipal Code, in the dining room including, but not limited to, DJs, musicians or patrons dancing. In the back room Licensee may engage in any activity permitted under City of Chicago Ordinances during private events not open to the public.
11. Licensee will not offer for sale "bottle service" of spirits/hard alcohol products for on-premises consumption. This paragraph in no way restricts the sale of beer or wine by the bottle.
12. Licensee agrees to not apply for a Late Hour liquor license.
13. Licensee shall work proactively with local police and the surrounding community with respect to law enforcement and community concerns. When necessary, Licensee shall meet with the local alderman, the police commander or the local residents to address any concerns regarding the operation of the establishment.
14. Licensee will keep a written log of all incidents inside and directly outside the premises. The owner shall produce a copy of this log to the Chicago Police Department or BACP/LLCC personnel upon request. The owner and/or restaurant host shall call 911 immediately upon an incident occurring inside or outside the premises that requires police intervention.
15. The Licensee shall adequately display the requisite "please respect your neighbors," "no loitering," and "exit quietly" signs near the exit of the restaurant.

16. The Licensee shall take steps to prevent the accumulation of litter by designating an employee to be responsible for the outside cleaning duties at the end of each night. The employee will be part of the full time staff and will be responsible for picking up any trash that is located in front of, adjacent to and behind the premises of the establishment.


The condition of the Consumption on Premises – Incidental Activity and Retail Food Liquor License issued pursuant to this Plan of Operation are legally binding and may be enforced by the City of Chicago enforcement authorities under Section 4-60-040 (h) of the City of Chicago Municipal Code. All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violation of the above stated conditions may also result in the issuance of Cease and Desist Orders prohibiting the activity which violates the conditions of the liquor license.


The conditions of the Consumption on Premises – Incidental Activity liquor license issued pursuant to this plan of operation shall apply to the business address and Licensee and to all officers, managers, members, and direct or indirect owners of the licensed entity. The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the license. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this Plan of Operation.

It shall be the duty of every person conducting, engaging in, maintaining, operating, carrying on or managing the above mentioned business entity to post this Plan of Operation next to the Consumption on Premises – Incidental Activity liquor license in a conspicuous place at the business address.
