The City of Chicago Department of Business Affairs & Consumer Protection/Local Liquor Control Commission and the above named licensee have agreed to the following license conditions concerning the operation of the business:

- 1. Licensee shall operate as a restaurant with incidental liquor service. The primary business activity will be the sale and service of food where alcohol sales and consumption will only be incidental. At no time will the business be operated in a manner where alcohol sales are the primary activity.
- 2. During all hours that the business is open to the public, the Licensee shall offer food preparation and service to its patrons.
- No employee, barkeeper or agent of the Licensee shall solicit, induce or request any
 patron of the licensed establishment to purchase any alcoholic or nonalcoholic beverage
 for him or herself or any other employee of the licensed establishment.
- 4. Licensee shall ensure that no employee, agent or patron of the licensed establishment engages in conduct which is designed primarily to appeal to the prurient interests of the employees, agents or patrons by engaging in explicit simulation of "specified sexual activities." "Specified sexual activities" includes, but is not limited to:
 - a. Lap dances;
 - b. Acts of human masturbation, sexual intercourse or sodomy:
 - c. Fondling or other erotic touching of human genitals, pubic region, buttock or female breast.

The conditions of this Plan of Operation are legally binding and may be enforced by City of Chicago enforcement authorities under the City of Chicago Municipal Code §4-60-040(h). All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions, unless otherwise agreed to, may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee.

The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the license. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this Plan of Operation.

It shall be the duty of every person conducting, engaging in, maintaining, operating, carrying on or managing the above mentioned business entity to post this Liquor License Plan of Operation next to the Liquor License in a conspicuous place on the licensed premises.
