Pursuant to the City of Chicago Municipal Code Section 4-60-040 (h) and 4-156-311 (d)3(A), the City of Chicago Department of Business Affairs and Consumer Protection (BACP) and the above named Licensee have agreed to the issuance of a Tavern license and a Public Place of Amusement license under the following conditions:

# 1. COOPERATION WITH POLICE, ALDERMAN AND COMMUNITY:

- a. Licenses shall immediately address any public nuisance issues which adversely impact the health safety, and welfare of the community.
- b. A representative from the Licensee shall serve as its Chicago Police Department public liaison. The liaison will hear all complaints (if any) filed by the community and seek to resolve all public nuisance matters. A log of all complaints or issues shall be kept and a record of the the resolution action taken.
- c. Licensee's officers shall attend regular CAPS meetings for the police Beat in which the premises is located.
- d. License shall immediately notify, by calling 911, their Police Department of any illegal activity viewed in and around the premises. License shall maintain a log of reports that include the date and time of the illegal activity observed, the date and time of Licensee's report to CPD.

#### 2. SECURITY:

Licensee shall have sufficient security on staff to monitor the interior and exterior of the premises. Licensee's security persons and employee' shall have the following duties and responsibilities:

- Observe the actions of Licensee's patrons
- Act to prevent excessive noise when patrons enter and leave premises
- Not permit intoxicated persons to enter premises
- Security personnel are required to document any and all incidents reported to the police and must be kept in a log
- All staff who serves alcoholic beverages and security persons shall be BASSET trained.
- Security personal shall wear clothing identifying them as "Security"
- Management will provide taxi services to any patron showing signs of intoxication.
- Licensee will announce "last Call" for alcoholic beverage sales and service at least 30 minutes prior to closing.
- Licensee shall make a public service announcement to all patrons 15 minutes prior to close
  of business to remind patrons of their responsibility to leave the Premises and the
  surrounding neighborhood promptly, quietly and in an orderly manner
- Licensee shall display a sign in a conspicuous location near the front door inside the premises that reads" Please respect our Neighbors, Please exit Quietly and Do Not Loiter".
- Licensee will post signage prominently at the entrance of the premises advertising patrons
  that firearms and other weapons are not permitted on the Premises and that all patrons are
  subject to search.
- Security and Licensee shall use "mechanical clickers" to monitor patrons both entering and exiting the Premises to ensure that occupancy is not exceeded.
- Licensee will ensure that any music played on the Premises conforms strictly to all relevant City of Chicago ordinances, including sound and other noise provisions. Licensee shall close all windows by 10pm.

### 3. CAMERAS:

Licensee shall maintain security cameras, with accompanying lighting that will monitor the interior, entrance and exits of the Premises. Licensee shall maintain said cameras in operating condition and store their video for 30 days. Licensee shall make videos available with 24 hours upon request by CPD or BACP

#### EMPLOYEES:

- a. All bartenders and servers shall be Basset or TIPS certified and shall produce certificates upon request by CPD or BACP
- b. All bartenders bouncers and employees will be trained to identify intoxicated patrons and will take pro-active steps to prevent the intoxication of patrons.
- c. Licensee shall at all times have a Manager who will be processed by BACP and meet all liquor license qualifications.

The conditions of this liquor license are legally binding and may be enforced by City of Chicago enforcement authorities under Section 4-60-040(h) and Section 4-156-311(d)3(A) of the City of Chicago Municipal Code. All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the

Licensee. Violations of the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the liquor licenses issued pursuant to this plan of operation shall apply to the business address and Licensee and to all officers, managers, members, partners and direct or indirect owners of the entity of which is licensed. The sale of the Licensee to other persons purchasing the stock of the licensed entity shall be subject to the same conditions set forth in this Plan of Operation. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this statement.

It shall be the duty of every person conducting, engaging in, operating, carrying on or managing the above-mentioned business entity to post this Liquor License Plan of Operation next to the Liquor License certificate in a conspicuous place at the business address.
