Pursuant to the City of Chicago Municipal Code Section 4-60-040 (h), the City of Chicago Department of Business Affairs and Consumer Protection ("BACP") and the above-named Licensee have agreed to the issuance of a Consumption on Premises — Incidental Activity Liquor License and Retail Food Establishment (collectively "Licenses") under the following conditions:

- Licensee shall operate as a restaurant where the primary business activity will be the sale and service of
 food and where the sale of alcoholic beverages will only be incidental to the food service. Licensee shall
 not operate in a manner where the sale of alcoholic beverages is the primary business activity. During all
 hours that the business is open to the public, the licensee shall offer food preparation and service to its
 patrons.
- 2. Licensee shall regularly monitor the exterior area around the premises during all of its business hours in order to address and abate noise, loitering, and littering complaints about Licensee's patrons or employees.
- 3. Notwithstanding Licensee's hours of operation, Licensee shall close all windows along Halsted Street and Belmont Avenue no later than 10:00 P.M. on each night. After twelve (12) months from the date the Licenses are issued, this Section 3 of the Liquor License Plan of Operation shall be reviewed by the local Liquor Control Commissioner and Licensee and, after considering the feedback from the local Alderman, this Section 3 may be stricken. In the event that this Section 3 is stricken, Licensee shall operate in compliance with the applicable provisions of the Municipal Code of Chicago.
- 4. Licensee shall store and remove garbage from the Premises on a regular basis and in compliance with the Chicago Board of Health Rules and Regulations and the Municipal Code of Chicago. Due care shall be taken by Licensee to limit noise and disturbance when garbage containers are being loaded and unloaded.
 - a. Licensee shall limit disturbances to nearby immediate neighbors by prohibiting employees from throwing away garbage bags containing all, or substantially all, glass bottles between the hours of 10:00 P.M. and 7:00 A.M.

- b. All employees will move and place garbage carefully and quietly into the dumpsters or trash containers so as to minimize noise.
- c. Recycling will be separated and kept in an orderly fashion.
- d. Licensee will regularly clean the area around the dumpster to abate vermin.
- 5. Licensee shall immediately notify, by calling 911, the Police of any illegal activity which it views in and around the Premises.
- 6. Alcohol Server Training. All bartenders and wait staff will be BASSET or TIPS certified, and will be trained with respect to the detection of fraudulent identification, such training shall be bi-annual regardless of each employee's term of employment. All bartenders and wait staff will be trained to identify intoxicated patrons and will take pro-active steps to prevent the over intoxication of patrons. Additionally, Licensee will not offer "Bottle Service" with regard to spirits.
- 7. Licensee shall regularly monitor the Premises to ensure compliance with the Municipal Code of Chicago and this Liquor License Plan of Operation.
 - a. Licensee shall take steps to ensure that patrons do not exit the Premises with any open alcoholic beverages. Patrons shall not be permitted to carry any open alcoholic beverage into the restrooms or any businesses adjacent to the Premises.
 - b. Licensee will display a sign in a conspicuous location inside the Premises near the restrooms that reads, "No Alcoholic Beverages Are Permitted Past This Point."
 - Licensee shall train employees to enforce Licensee's policy that open alcoholic beverages are not permitted outside of the Premises including the restrooms or any businesses adjacent to the Premises.
- 8. Licensee shall, at all times it is open to the public, provide patrons with access to restrooms. Licensee must immediately notify BACP should Licensee no longer have unrestricted access to the restrooms located within the building.
- 9. The Licensee will enforce all applicable City and State non-smoking laws as they relate to both the interior and the exterior of the Premises.
- 10. This Plan of Operation will be reviewed by the Alderman and Licensee twelve months after the date this Plan of Operation is approved.

The conditions of this liquor license are legally binding and may be enforced by City of Chicago enforcement authorities under Section 4-60-040(h) of the City of Chicago Municipal Code. All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violations of

the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the liquor licenses issued pursuant to this plan of operation shall apply to the business address and Licensee and to all officers, managers, members, partners and direct or indirect owners of the entity of which is licensed. The sale of the Licensee to other persons purchasing the stock of the licensed entity shall be subject to the same conditions set forth in this Plan of Operation. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this statement.

It shall be the duty of every person conducting, engaging in, operating, carrying on or managing the abovementioned business entity to post this Liquor License Plan of Operation next to the Liquor License certificate in a conspicuous place at the business address.
