Pursuant to the City of Chicago Municipal Code Section 4-60-040 (h), the City of Chicago Department of Business Affairs and Consumer Protection (BBACP) and the above named Licensee have agreed to the issuance of a Package Goods Liquor License under the following conditions:

- 1) The Licensee continues its normal hours of operations and agrees to cease all sales of alcoholic liquor no later than 10pm Sunday through Thursday and no later than midnight on Friday and Saturdays.
- 2) The Licensee shall not sell "single serve" or small containers, such as less than pints, alcoholic beverage products.
- 3) The Licensee shall not sell the following liquor:
 - a. Fortified Wines: including but not limited to Wild Irish Rose, Night Train, Italian Swiss, Gallo, Taylor Port and White port, MD20/20, Cisco, Cool Breeze, Thunderbird, Sunset Grain Alcohol and other such products;
 - b. Special Brews: including, but not limited to St. Ives, Steel Reserve 211, Sparks, Juose, Axe Head, Camo Black, Cobra or Kokoloko.
- 4) Licensee shall not post promotional signage on the windows of the Licensed Premises advertising the sale of alcoholic beverage products at discounted prices.
- 5) All employees having any responsibility for any alcoholic beverage service will be Basset Certified and will receive additional in-house training and education on proper ID-checking techniques.
- 6) Licensee shall require any person seeking to purchase alcoholic beverage products who appears to be under the age of forty (40) to produce a valid form of government-issued identification which includes a photograph of the person, his or her date of birth and the person's full name.
- 7) Licensee shall deny entry to any person who is visibly intoxicated and notify local police of all unlawful acts witnessed by, or reported to, any of its employees.
- 8) Licensee shall ensure appropriate on-site security to ensure limited loitering.

9) Licensee shall commit to a community process to address concerns raised by the community.


10) Licensee shall establish a routine clean up schedule for the establishment

The conditions of the Package Goods Liquor License issued pursuant to this Plan of Operation are legally binding and may be enforced by the City of Chicago enforcement authorities under Section 4-60-040 (h) of the City of Chicago Municipal Code. All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violation of the above stated conditions may also result in the issuance of Cease and Desist Orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the Package goods license issued pursuant to this Plan of Operation shall apply to the business address and License and to all officers, managers, partners, and direct or indirect owners of the licensed entity. The sale of the business to other persons purchasing the stock or membership units of the licenses entity does not void the conditions of the license. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this Plan of Operation.

It shall be the duty of every person conducting, engaging in, maintaining, operating, carrying on or managing the above mentioned business entity to post this Package Goods license plan of operation next to the Package Goods license in a conspicuous place at the business address.
