Pursuant to the City of Chicago Municipal Code Section 4-60-040 (h), the City of Chicago Department of Business Affairs and Consumer Protection (BACP) and the above-named Licensee have agreed to the issuance of a Package Goods liquor license, under the following conditions:

<u>Operations:</u> Licensee has applied for a Package Good Liquor License and has represented to the Local Liquor Control Commission (LLCC) that it will comply with all codes and ordinances of the City of Chicago and will conduct its business in a manner that respects and contributes to the surrounding neighborhood.

Hours of Operation: In consideration of the agreement, Licensee agrees that alcoholic beverages will only be sold during the following hours:

Monday – Thursday

9:00 am - 11:00 pm

Friday – Saturday

9:00 am - 12:00 am

Sunday

11:00 am - 11:00 pm

Adherence to City of Chicago Regulations: Licensee shall be the best neighbor it can be, complying with all City of Chicago laws, rules and regulations, including but not limited to the occupancy of the premise, Noise and Vibration Control Ordinances (08-32) and smoking laws. Licensee shall regularly monitor the exterior area around the Premises during all of its business hours in order to address and abate noise complaints from the residential community.



<u>CAPS and Community Business Meetings:</u> Licensee shall attend all regular Community Alternative Policing Strategy (C.A.P.S) beat meetings, Business Meetings and shall setup and/or attend meetings with the local Alderman, 019th District Police Commander, Law Department, or any other City department personnel to discuss any problematic concerns regarding the operation of the business, if needed.

<u>Cleanliness:</u> The licensee will monitor the area around the business and the nearby area from open to close and keep it clean, free of garbage and debris. Garbage will be picked up by a private waste management company on a timely basis insuring no overflow of garbage from the business.

<u>No Loitering or Trespassing Tolerated:</u> Licensee shall ban unauthorized people from loitering and trespassing and shall enforce the ban by instructing unauthorized people to leave and shall call the CPD if they do not obey. For purposes of this Plan, loiterers and trespassers are persons who are not purchasing products from the Licensee or who linger beyond a reasonable amount of time after making a purchase.

<u>Windows:</u> Licensee agrees that it is familiar with and shall abide by the Municipal Code of Chicago § 13-020-550 which limits advertising signs on exterior facing windows to no more than 25% of any single window and allowing unobstructed view into the interior of the premises.

<u>Lighting:</u> Licensee shall provide sufficient outdoor lighting in the front, back and side of the premises to provide for the safety of patrons and staff and deter loitering and illegal activity.

<u>Staff Training:</u> Licensee agrees that all staff who may serve alcoholic beverages will be certified with BASSET or TIPS training and will be trained with respect to fraudulent identification.

<u>Non-Smoking Laws:</u> Licensee will enforce all applicable City and State non-smoking laws as they relate to both the interior and the exterior of the Premises. The licensee shall ban persons which become known to them to not comply with the municipal code regarding the sale of cigarettes on the public way in the vicinity of the premise.

<u>Security Cameras:</u> Licensee shall install and maintain an external security camera system and shall allow Chicago Police Department (CPD) personnel access to security cameras upon request and to connect their external camera feed through the Office of Emergency Management and Communication (OEMC) in accordance with the "Private Sector Camera Initiative." All video footage must be maintained for at least 30 days.



<u>Intoxicated Persons:</u> The licensee shall comply with 235 ILCS 5/6-16(a)(i) by not selling, serving, or giving away alcoholic beverages to any intoxicated person.

<u>Public Drinking:</u> The licensee shall ban persons which become known to them to not comply with the municipal code regarding the drinking of alcohol on the public way in the vicinity of the premise. Signs prohibiting such activity shall be posted and incidents should be reported be calling 911.

Report to Police: The licensee shall report all illegal activity as described in MCC 4-4-306 and 4-60-141 to the Chicago Police Department by calling 911.

<u>Incident Log:</u> The Licensee shall maintain a written log documenting any incidents or possible unlawful activity in or outside the licensed Premises, and the Licensee shall immediately contact the police if any illegal activity occurs inside or outside the licensed Premises. The log will be made available to the Chicago Police Department or the Department of Business Affairs and Consumer Protection upon request.

Restricted Sales: Licensee agrees not to sell the following liquor and non-liquor items:

Fortified Wines: including but not limited to, Wild Irish Rose, Night Train, Italian Swiss, Gallo, Taylor Port and White Port, MD20/20, Cisco, Cool Breeze, Thunderbird, Sunset Grain Alcohol, Boone's Farm Sunshine Pink and Snowcreek Berry.

Special Brews: all high-gravity malt liquors, including but not limited to, St. Ives, Steel Reserve 211, colt 45, Sparks, Juose, Schlitz, Axe Head, Camo Black, Cobra, KoKoloko, 4-pack of Old English and Steel Reserve.

Prohibited Beverages: "single serve" alcoholic beverage products in violation of 4-60-140(i); all 32-ounce beers; 40-ounce beers for less than \$3 per bottle; 12-ounce 6 packs for less than \$3.50.

Prohibited Products: Plastic, paper or Styrofoam cups in packages with less than 20 cups.



The conditions of the packaged goods liquor license issued pursuant to this agreed plan of operation are legally binding and may be enforced by the City of Chicago enforcement authorities under MCC 4-60-040. All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the Licensee. Violation of the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the packaged goods liquor license issued pursuant to this plan of operation shall apply to the business address and license and to all officers, managers, partners, and direct or indirect owners of the licensed entity. The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the license. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this pan of operation.

It shall be the duty of every person conducting, engaging in, maintaining, operating, carrying on or managing the above-mentioned business entity to post this plan of operation next to the liquor license in a conspicuous place at the business address.
