Per Chapter 4-60-040(h) of the City of Chicago Municipal Code, the Local Liquor Control Commission has authorized the issuance of a Packaged Goods License to the above named business entity and business location under the following conditions:

I. The licensee agrees to the following hours of operation:

Monday through Thursday:	7:00am to 9:00pm
Friday and Saturday	7:00am to 10:00pm
Sunday	7:00am to 10:00pm

During periods of time outside of the above stated hours of operation, the business must be closed with no patrons permitted inside the premises for any reason including, but not limited to, the consumption of food or alcoholic beverages.

- II. Licensee shall comply with all statues, ordinances and regulations relating to identification of persons seeking to purchase alcoholic liquor.
- III. Licensee shall require that any person, who seeks to purchase alcoholic liquor on the licensed premises and appears to be under the age of thirty (30), produce two forms of

identification, one which includes both a photograph of the person and a date of birth, and a second that includes the name of the person.

- IV. Licensee shall not sell tobacco products, lottery tickets or energy drinks.
- V. Licensee shall continually remove all litter and trash from the public way in front of the licensed premises.
- VI. Licensee shall not place or maintain any neon signage or flashing signs in or on the windows of the licensed premises.
- VII. Licensee shall continually remove all litter and trash from the public way in front of the licensed premises.

The conditions of this license are legally binding and may be enforced by City of Chicago enforcement authorities under MCC 4-60-040(h). All other conditions of the license are governed by the City of Chicago Municipal Code. Violation of the above stated conditions may result in the imposition of a fine and/or suspension or revocation of all business licenses issued to the licensee. Violations of the above stated conditions may also result in the issuance of cease and desist orders prohibiting the activity which violates the conditions of the liquor license.

The conditions of the liquor license shall apply to the business address and licensee and to all officers, managers, partners and direct or indirect owners of the entity of which is licensed. The sale of the business to other persons purchasing the stock or membership units of the licensed entity does not void the conditions of the license. Any and all potential new owners of the licensed entity shall be subject to the same conditions set forth in this statement. In addition, no application for a change of officers or ownership application will be approved until and unless a





