



CHICAGO Food Truck Stand Map

- “Mobile Food Stands” are designated parking locations where Food Trucks with a current Mobile Food Preparer or Mobile Food Dispenser business license may operate.
- Operators may park in the Food Stands as well as in legal parking spaces throughout the City for up to 4 hours.
- All [Food Truck Ordinance](#) regulations apply when using Food Stands except for the requirement to park at least 200 feet from a restaurant.
- Vehicles that are not Food Trucks cannot park in designated Food Stands.
- Food Trucks cannot park in other locations on a block that includes a designated Food Stand

Food Stand signs are installed within a full block of the following address locations, according to section [7-38-117](#) of the municipal code
