- The purpose of the RFP is to identify an entity to provide such dispatch services, which, in addition to providing a means of summoning WAV taxicabs by telephone, will include the ability to hail WAV taxicabs electronically.
- The selected Respondent will be contracted to provide a centralized dispatch service for WAV taxicab vehicles as defined in the RFP.
- The goal of the Centralized WAV Taxicab Dispatch Service is to ensure a swift response to a passenger's request for WAV taxicab service by timely connecting the passenger with a City licensed WAV taxicab.
- BACP is seeking Respondents to provide onsite (Chicago based location) management; technology and equipment; and oversight and coordination of the Centralized Wheelchair Accessible Vehicle (WAV) Taxicab Dispatch Service.
- Pursuant to Municipal Code of Chicago Section 9-112-570 "Taxicab wheelchair accessible vehicles and centralized wheelchair accessible dispatch", the BACP Commissioner is authorized to regulate a centralized dispatch system for wheelchair accessible vehicle taxicabs.

BACP is committed to providing accessibility for all individuals, including people with disabilities.
