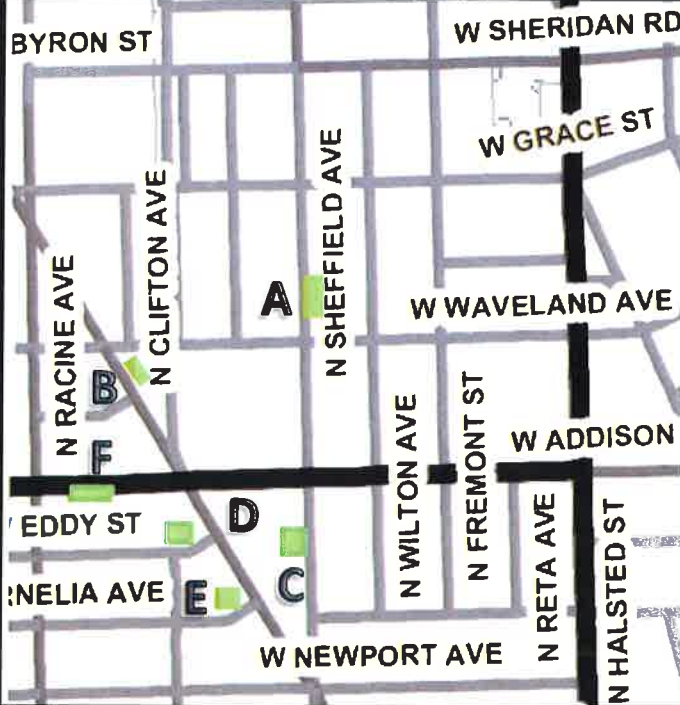

A	Sheffield 30ft north of Waveland east curb. Do not block lot access, and no more than 5 Cabs.
B	Clark St. 50ft south of Waveland east curb. No more than 5 Cabs.
C	Sheffield west curb lane at least 150ft south of Addison. No more than 5 Cabs. Cabs must head south on Sheffield to exit area.
D	Eddy and Clark must not use Clark if closed to traffic must exit area south on Clark without stopping. No more than 10 cabs.
E	Cornelia and Clark must head west on Cornelia to exit area. No more than 10 cabs.
F	On Addison North curb, west of the west Alley of Clark when Addison street is closed to eastbound traffic. Must Exit west on Addison. No more than 10 cabs.

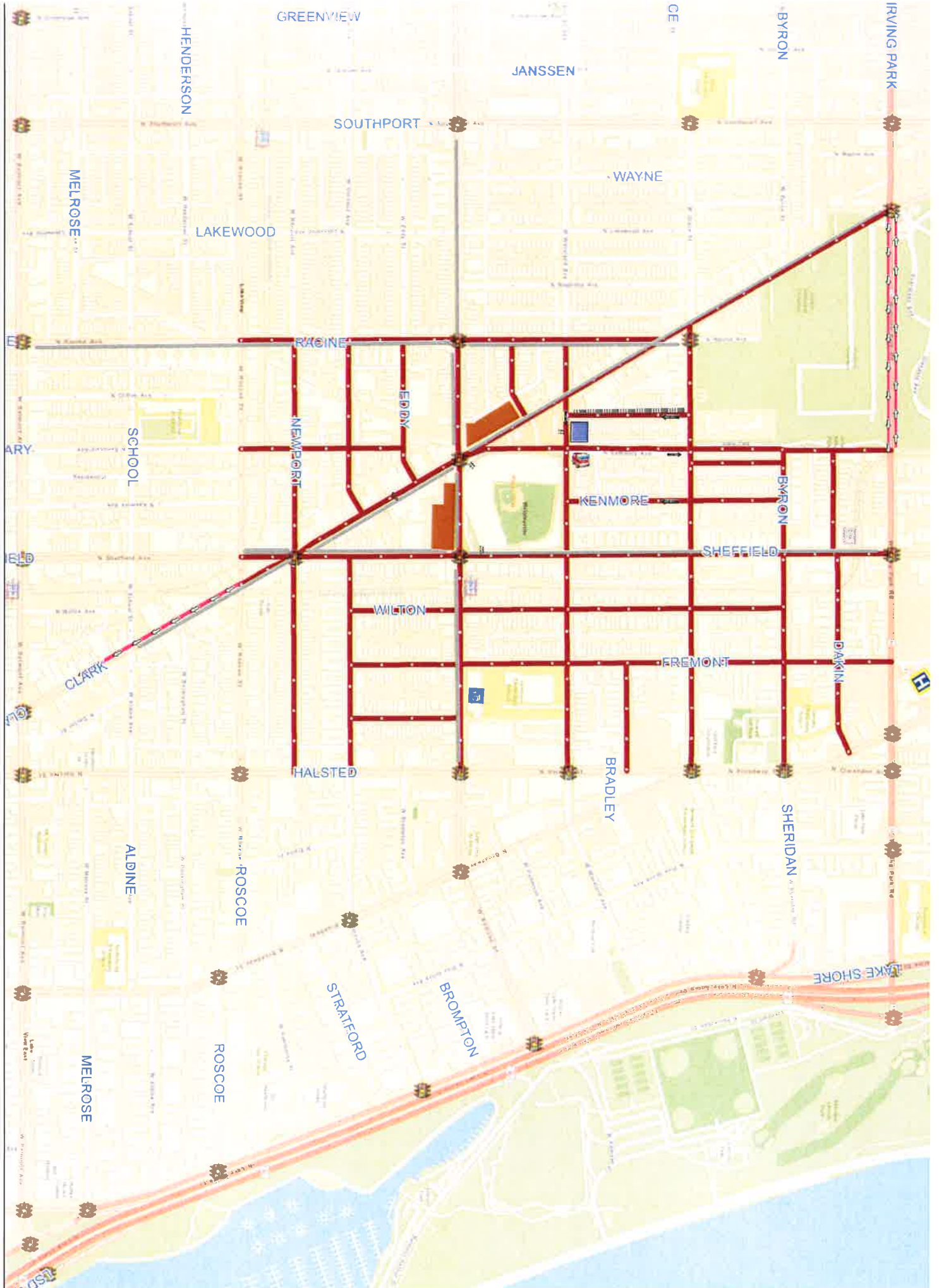
