#### **STATE OF ILLINOIS FACE COVERINGS REQUIREMENTS**

On April 23, 2020, Governor Pritzker announced an extension of the Illinois Stay at Home Order to May 31, 2020. Under this extension, there are important modifications to the Stay at Home Order that go into effect on May 1, 2020. These modifications provide new guidelines to protect workers and consumers.

### **NEW Requirement to Wear Face Coverings effective May 1, 2020**

All individuals over the age of two that can medically tolerate face covering will be required to wear a face covering over their nose and mouth when they are:

- in a public space and unable to maintain a six-foot social distance; or
- in any indoor public space.

In accordance with the Governor's Stay at Home Order and above listed CDC guidelines, public chauffeurs providing transportation services should wear face coverings. Passengers should also wear face coverings in public vehicles.
