SCHEDULED VEHICLE INSPECTIONS RESUME AT 39TH STREET ON AUGUST 10, 2020

- On Monday, August 10, 2020, BACP's Public Vehicle Inspection Facility at 2420 W. Pershing (39th Street) will resume performing BACP scheduled vehicle inspections.
- BACP has rescheduled public vehicle inspections previously scheduled between March 19, 2020 and August 7, 2020.
- The updated list of scheduled vehicle inspections for taxicabs and liveries is posted at Chicago.Gov/BACP and is attached to this notice.
- Between July 27 and August 7, 2020, the Public Vehicle Inspection Facility will inspect vehicles and advertising equipment by appointment only. Request an appointment by emailing <u>BACPPV@cityofchicago.org</u>.
- Public passenger vehicle licensees may request inspection date scheduling changes by sending an e-mail to <u>BACPPV@cityofchicago.org</u>.
- BACP's Public Vehicle Licensing Facility at 2350 W. Ogden Avenue remains closed to the public. BACP staff continues to work servicing licensees and performing essential functions. Renew public chauffeur or public vehicle licenses by e-mailing <u>BACPPV@cityofchicago.org</u>.

COVID-19 Protocols: What to expect and bring to a BACP office or facility

Any person visiting the Public Vehicle Inspection Facility must wear a face covering over their nose and mouth and should bring a pen to complete forms and paperwork.
