Taxi, Livery, and Ambulance Vehicle Inspection Schedule is on the City's Data Portal!

The Department of Business Affairs and Consumer Protection (BACP) is excited to announce that the **Public Passenger Vehicle Inspection Schedule** is now published on the City of Chicago's Data Portal. View and explore interactive scheduled vehicle inspection dates for taxis, liveries, and ambulances.

- BACP Public Vehicle Inspection Facility (39th Street) scheduled inspections of taxi, livery, and ambulance inspections are in a new on-line format which allows searches by license/vehicle number, by company, or by affiliation.
- The new on-line format inspection schedule is updated daily and will display current inspection dates.

Options to view and search a vehicle inspection date and time:

- 1. Start at the City of Chicago data portal website: <u>data.cityofchicago.org</u>
 - Search to find a specific dataset...
 - > In search box, type "Public Passenger Vehicle Inspection Schedule" and hit enter
- 2. Click and bookmark this direct weblink to the Public Passenger Vehicle Inspection Schedule: <u>https://data.cityofchicago.org/Community-Economic-Development/Public-Passenger-Vehicle-Inspection-Schedule/kxfh-a6zz</u>
- 3. For taxi vehicle inspections, these two views were specifically created to facilitate searches. Click and bookmark:

View 1 is best if you know the Public Vehicle Number you are trying to find. For example:

View 2 also allows for saving a search simply by bookmarking the page once you have it the way you like it. A common use of this feature may be to save a set of vehicles you wish to search repeatedly.
