- H. Owen CRISP helped 176 animals in the program with less then 20% are direct referrals from CACC and other 80% from animal hospitals. Will be doing a training for CACC staff on who to refer to CRISP.
- C. Propsom Reason for Friends is to call attention to the good things at CACC. Been successful with
  donations, purchased a new washer and dryer, working on repairing some scanners, participated in
  vaccine clinics, off-site adoption events, foster program to help CACC, After Hours Crisis Care Program.
   M Diakhate thanked Charlie from FCACC for the money and time she puts into the After Hours Crisis
  Care Program. FCACC is also supplying the funding of a Volunteer Coordinator for the shelter.

Below are the responses to your questions from the Nov 17<sup>th</sup> Commission meeting. Please note that the Public Comment portion of the Commission meeting is for public comment on agenda items for that meeting, not for department specific questions. CACC is working on making that more clear on our website. The department will attempt to answer questions or address situations as they are asked.

#### **CACC Admin and Staff-**

• You are Chicago Animal Care and Control. Not Chicago Dog Care and Control. People continue to be refused intake for cats, which is against the city ordinance. How are you addressing this?

CACC does not turn away cat intakes. We do provide alternatives to clients who bring cats to the facility. In fact, for the year of 2022, CACC took in a total of 5,336 cats. Of the 5,336 cats, at least 4,102 were taken in at the front desk, of the 4,102 cats taken in at the front desk, at least 3,063 were stray cats.

• Why is CACC closing out stray cat calls stating "CACC does not apprehend community/feral cats or kittens"? Who gives dispatch permission to close out/cancel calls?

Please provide examples of these calls so we may investigate.

• Rumor has it that ACOs are going to be doubling up in their trucks for shifts and their shift hours are going to change. Is this true?

CACC does not respond to rumors.

- How many hours does the Operations Manager spend in the field per week?
   Attached is the job description of the Operations Manager Animal Control. This position is not required to go into the field.
- Staff is still not signing emails when responding to the <u>visitcacc@cityofchicago.org</u> emails
   Please provide recent examples as all staff with access to that email have been advised to sign the emails.
- Why aren't all microchips of stray animals picked up by ACOs being researched while in the field instead of waiting until they get to the shelter?

There are times when we don't have staff available to perform the microchip research or microchips are missed, in these cases, the research will be done at the shelter. Additionally, we are in the process of upgrading our scanners and are looking forward to returning more animals in the field.

Note that in answer to a similar question to S&S prior to the November 2022 meeting, Ms Cruz reported that DOA animals from S&S are not counted unless the animal has a microchip.

• Why does it take 2 months to get answers when I'm the only person writing/calling in?

From the Commission Chair:

- · I don't know that you are the only person writing/calling in.
- NOTE: We have said in the past that responses could be expected no later than the next regular meeting following the submission of comments to askcacc.
- Why again is it hard to communicate sending a link to call in?

From the Commission Chair:

- · The Department responds to comments for the Department emailed to askcacc. Since the COVID-19 emergency, the Department has taken on sending out the link to call in to a virtual meeting to those who email askcacc within the guidelines stated on the website.
- Why are commissioners allowed to miss several meetings a year when you only meet once every 2 months?

From the Commission Chair:

- · There is no set number or sequence of meetings that Commissioners must attend. We neither allow nor not allow attendance at meetings. Commissioners are expected to attend every meeting.
- Why are these meetings still not being held in person?

The Commission resolved at the November 2022 meeting to meet in person at least once a year.
