CCHR REOPENS TO THE PUBLIC



On September 21, 2020 the CCHR reopened its office to the public on a limited basis. CCHR PARTNERS WITH IAOHRA TO HOST CIVIL RIGHTS WEBINARS

During the summer of 2020, the CCHR joined with the International Association of Official Human Rights Agencies (IAOHRA) to produce two highly successful webinars addressing civil rights challenges during the pandemic. The first program was a virtual town hall meeting, "Human Rights in an Era of Uprisings and the Pandemic" on June 26, 2020. Speakers included Derrick Johnson, National President of the NAACP and Catherine Lhamon, Chair of the U.S. Commission on Civil Rights.


The second webinar, "Fair

Housing Matters: The Challenge of Housing Access in a Racially Divided Nation During COVID-19" was held August 13, 2020. The speakers included a panel of national leaders in Fair Housing including Anna Farias, HUD Assistant Secretary, Fair Housing and Equal Opportunity, and Chicago's own Professor Michael Seng, UIC-John Marshall Law School. More than 1,000 people from across the country participated in the webinars.



SOUTHSIDE NOT IMMUNE FROM SECTION 8 DISCRIMINATION, STUDY FINDS





In a recent study conducted for the CCHR by the Roosevelt University Policy Research Collaborative, fair housing testing found discrimination against persons seeking to use Housing Choice Vouchers (HCV) (aka Section 8) on both the North and South sides of Chicago. The study sought to determine in part, the prevalence of discrimination against participants in the Federal Housing Choice Voucher Program

administered locally by the Chicago Housing Authority (CHA). The study used a sample of four community areas in the city with high concentrations of rental units, two on the Northside (Rogers Park and Logan Square) and two on the Southside (Chatham and Grand Boulevard). The tests for the Northside also looked at discrimination based on race and national origin.

The study found that HCV holders faced discrimination on both the North and the South sides, which suggests that race is often a factor in HCV discrimination, but not the only factor as Black HCV holders were discriminated against by Black landlords and real estate managers on the Southside. The study also showed in the Northside tests, White HCV holders were more likely to receive better customer service, while Black HCV holders encountered more obstacles when trying to rent units. COMMUNITY TENSION MEDIATION & EDUCATION WORKSHOPS

A Virtual Success

When it comes to tension among communities, it is essential to hear both parties clearly and create the possibility of a cordial conversation between them. The Community Mediation program under CCHR's Inter-Group Relations (IGR) Unit focuses on creating a dialogue between two parties involved in a conflict, which is arranged by a member of our team. The role of our community mediation specialist is to facilitate a conversation in a safe and confidential manner, while remaining completely neutral, where both parties feel heard and can express their concerns without the fear of being held accountable. Even though the focus of mediation is often aimed at reaching a mutually agreed upon resolution by the end of a session, it is not the goal of a mediation. Having the conversation is what's important.

With COVID-19 rapidly taking over our lives, virtual conversations have become the new "normal." That being said, all our mediation services have been moved to Zoom since the pandemic. Despite being completely virtual because of safety reasons, our mediation services have still been running smoothly and successfully. During the pandemic, IGR has continued to mediate many disputes, most often involving neighbors at odds with each other. IGR provides a platform for the parties to discuss their issues and decide what necessary steps they are willing to take in order to improve the situation.

In addition to mediation, IGR is also offering virtual workshops on Zoom which help educate individuals on issues that are prevalent in today's social environment such as bullying and implicit bias. These workshops are catered towards a range of age groups and communities - children, youth, adults, seniors, administrators and staff;
