Summary updates

Updates:

Investigation for Trinity Washington is still being looked into. Commander Betancourt will hear from them as soon as there are any further updates, however, it is up to the detectives to let us know what comes next.

Kiisha as FOIA'd the records. Kiisha spoke on the incident on 10/1/23 over at Home Runn Inn. And on 10/2/23 with the stabbing on pink line, which was reported as a hate crime. 10/13/23 there was a black and brown unity march that was held outside the station.

Commander Betancourt: There have been flyers posted on the CTA. It was some sort of machete style knife after asking if the defender was alright. There has been canvassing throughout the neighborhood. There was no sight or further information when the attacker took the bus. Again, no one has come back to report anything to the commander.

There was a handout on the Problem with Traffic Enforcement in Chicago. The presenter did not show, but there were handouts that were distributed.

- A representative from Sankofa House was inquiring why the Alderwoman does not show for the 24th Ward.
- In regard to policies about the commissions could potentially advocate for and there was mentioning of adequate bike lanes and the ending of pre-textual stops. In addition revisit the illegal stop and frisk conversation with the interim commission.
