





The Existing Order:

Name: "Prohibition on Associations with Criminal Organizations" (G08-03)

Police officers are not allowed to be members or "associate" with members of criminal organizations.

The existing order does not clearly define "criminal organization" or what it means to "associate" with a criminal organization.

CPD decides which groups are "criminal organizations" based on crime patterns and information from officers and informants.

CPD uses several factors to decide if someone is a member of a criminal organization, including emblems, tattoos, the use of signals or symbols, and information from informants.

CPD requires documented and reliable information to prove that an officer is associating with a criminal organization.

Officers are required to report any violations of this order to supervisors or file a complaint.

CPD's Proposed Changes:

The proposal makes the rule clearer by defining "criminal organization" as...

- A group that takes part in regular criminal activity;
- A "street gang";
- A group that uses or promotes violence to deny people's rights or to achieve ideological goals;
- A group that uses or promotes terrorism to overthrow the government;
- A group that promotes illegal prejudice, oppression, or discrimination; or
- A group that prevents or interferes with the performance of police duties.

CPD would be able to discipline or fire police officers for doing or associating with people who do the following:

- Recruiting, fundraising, or donating to support a criminal organization;
- Attending events or being an organizer for the criminal organization;
- Promoting or supporting the criminal organization, including via social media.

Each District Council shall:


- Hold public meetings at least monthly to discuss policing issues
- Work with the Police District Commander and community members to help develop and implement community policing initiatives
- Work to develop and expand restorative justice and similar programs in the District;
- Encourage Department members to facilitate access to community resources
- Assist and engage with members of the public, including gathering input from the public regarding public safety and policing in their district

District Council Members may...

- respond to community members' questions and concerns by requesting information related to investigations from the Department or COPA
- provide information to Department members and community groups on the work of the Commission and District Councils

Finding Types

Sustained: The allegation was supported by sufficient evidence ("Preponderance") to justify disciplinary action. Recommendations of disciplinary action may range from Violation Noted, to Suspension, to Separation from the Department.

Not Sustained: The allegation is not supported by sufficient evidence ("Preponderance") to prove or disprove the allegation.

Unfounded: The allegation was not supported based on facts revealed through investigation, or the reported incident did not occur, as shown by "Clear and Convincing Evidence."

Exonerated: The incident occurred, but the action taken by the officer was lawful and proper, as shown by "Clear and Convincing Evidence."

The table below depicts the outcome of misconduct investigations during Q2 2023 broken down by allegation type and finding.

Police Board Review Decision

The Chicago Police Board is tasked with deciding disciplinary cases when the Superintendent of Police files charges to discharge a sworn officer from the Department and rules on disagreements between the COPA Chief Administrator and the Superintendent of Police. During instances of disagreement between the COPA Chief Administrator and the Superintendent of Police, a single Police Board Member decides if the Superintendent of Police met the burden to overcome the Chief Administrator's recommendation. If the Superintendent does not meet this burden, the Chief Administrator's recommendation shall be deemed accepted by the Superintendent; if the recommendation is to discharge the officer from the Department, a case is to be filed for hearing and consideration by the full Police Board. If the Superintendent meets this burden, the Superintendent's response shall be implemented. In Q2 2023, the Police Board decided on nine COPA-investigated discharge cases and one disagreement case.



16th State Representative District Public Safety Advisory Council:


