<u>Parker-</u> Spoke about the 5 working groups amongst the DC's. SRO programs, three schools are affected in our district. SRO will end this school year.

Bielecki- Mayor Johnson missed the April 7th deadline to announce the seven new permanent members of the commission. With no definite date of when the announcement will be. As a member of the nominating committee, I feel like this a bit of disrespect toward the nominating committee since we met all our deadlines on time. Spending many long hours in the process. On the topic of ShotSpotter, the District Council public safety group is following the plan is to set up a meeting with head of the Police/Fire committee. To discuss the future of ShotSpotter and the desire for communities to continue the contract. Wards in the city do want to retain the technology.

Discussions:

<u>Commander-</u> The 22nd district continues to take illegal guns off the street, currently at 129 guns this year. Spoke about the SSI parade. Zero arrest and Zero property crime reported this year for a successful parade. 22nd District CPD raised \$10,000 for special Olympics at this year's polar plunge. Upcoming events in our district will include the ridge run and breast cancer walk. Spoke about the homicide on 95th Vanderpoel. Spoke about 111th western self-inflicted gun shot wound in the AirBnB. CPD met with metra to increase safety. Metra social worker will address the homelessness. Marshfield plaza safety concerns- they are adding security gates, CPD will now criminally trespass in that area.

<u>Yvette Loizon-</u> Gave a recap on the ShotSpotter hearing. April 17th it should be voted on by city council. Spoke about the recent police shooting.
