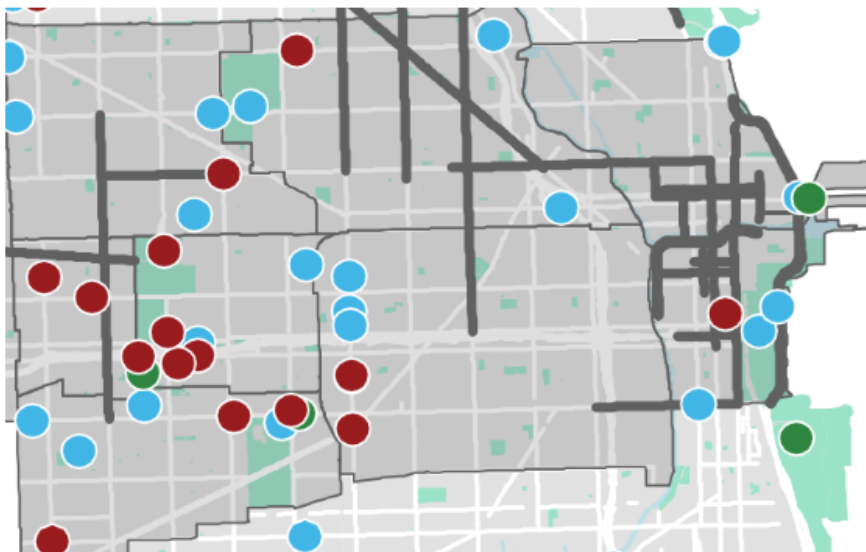

## ★ DATA RESOURCES ★

### Increasing Transparency



CDOT makes information about traffic safety available to the public. Findings from monthly fatal traffic crash analyses, links to commonly referenced datasets, and links to the City's Open Data Portal can be found below.

### Fatal Monthly Crash Summaries

Each month CDOT creates a summary of traffic deaths that occurred in the previous month. Summaries include:

- A break-out of the fatalities by travel mode
- A citywide map of that month's fatal crash locations
- Year-to-date totals and comparisons with prior months and years
- Year-over-year comparison charts for crashes

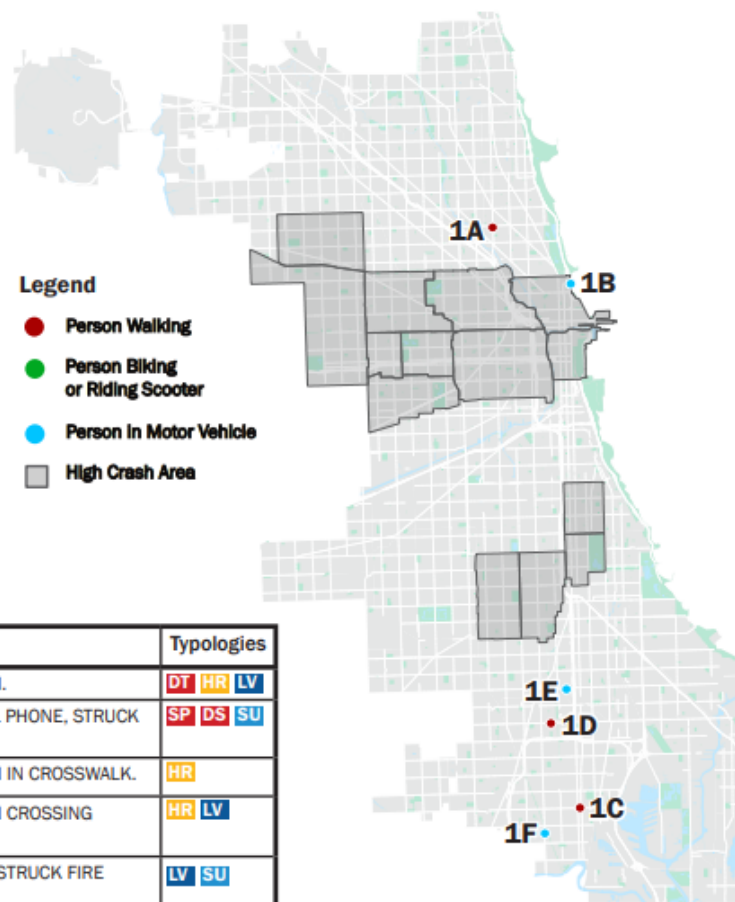

### About this Report

The Chicago Department of Transportation (CDOT) conducts a timely analysis of fatal traffic crash reports furnished by the Chicago Police Department (CPD) to understand the circumstances associated with such crashes. Based on these analyses, CDOT has identified trends, patterns, and correlations associated with each fatal traffic crash. These factors are then grouped into fatal crash typologies as listed to the right. Classifying crashes based on these typologies is among the preliminary outcomes of the analysis process and supports CDOT's efforts to develop relevant and data-informed actions to increase traffic safety. This report provides summary information related to fatal traffic crashes reviewed and analyzed by CDOT that occurred in the month specified.

- SP** Speeding
- DT** Disregard Traffic Signal/Sign
- DS** Distracted
- HR** Hit & Run
- SU** Single-Unit Crash
- LV** Striking Driver in Large Vehicle

## \* SCHOOL ZONE IMPROVEMENTS \*



### CURB BUMP-OUTS

Make streets narrower to slow down drivers and shorten crossing distance for people walking.



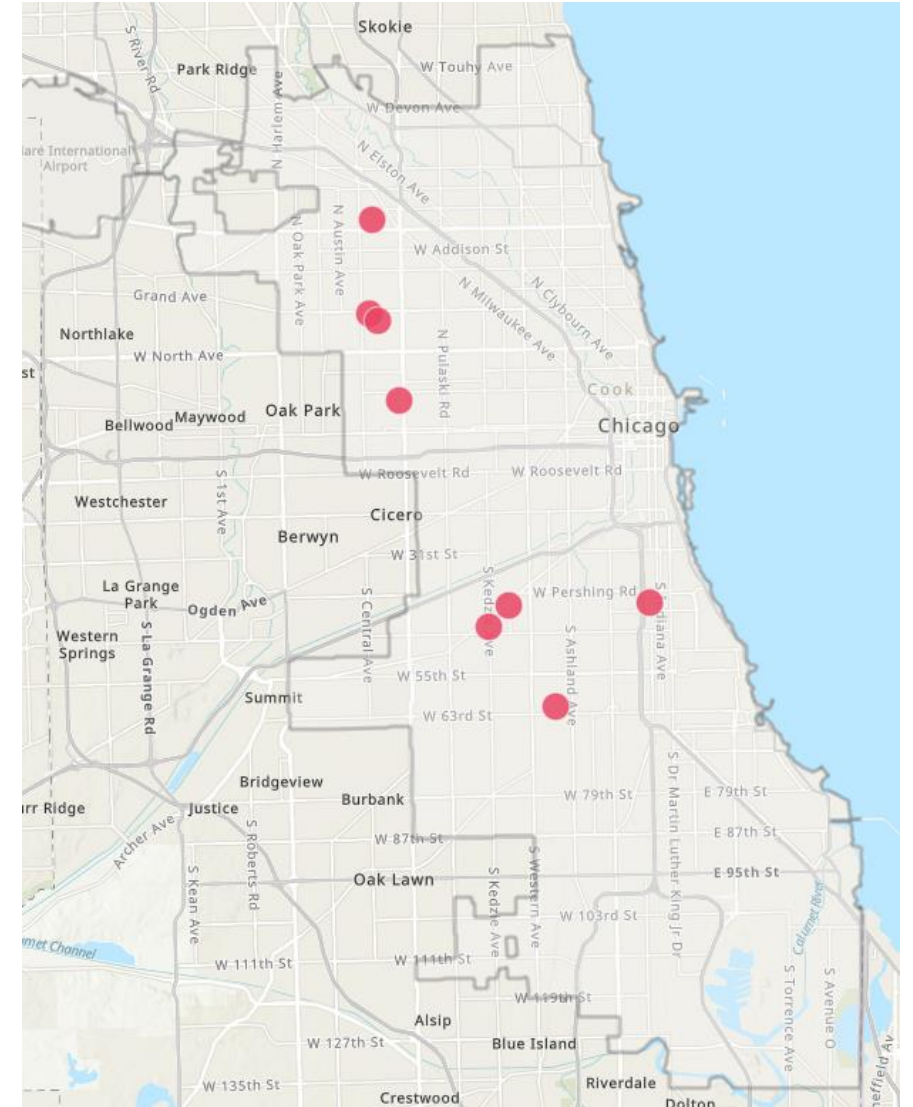
### RAISED CROSSWALKS

Encourage drivers to slow down before the crosswalk and enable people walking to cross the street at sidewalk level.



### REFUGE ISLANDS

Make it easier to find gaps in traffic when crossing a two-way street.

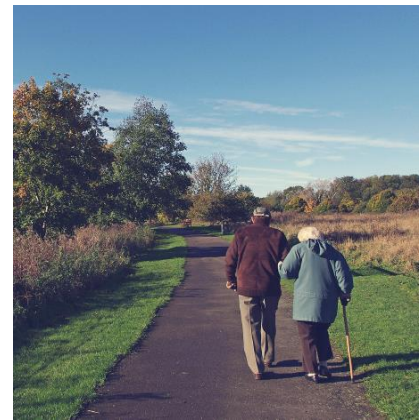
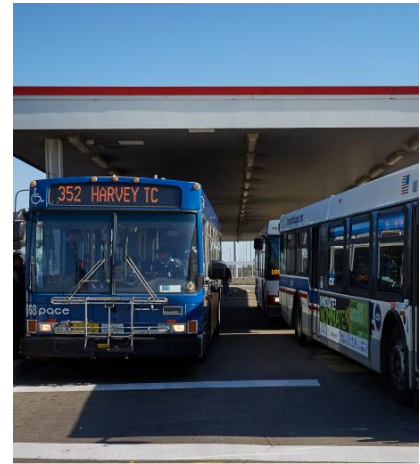
