OVERVIEW OF WORK

IPHI has been contracted by CDPH to provide supports for project coordination and analysis for Chicago's CIA during three phases of work: Scope, Assess/Design, and Report.

IPHI will be a partner in the project management team and working groups. IPHI will report to CDPH and the CIA project management and accountability structures (Environmental Equity Working Group- EEWG), with CDPH's Health Equity in All Policies team supervising IPHI's work. As such, IPHI's scope and activities will be responsive to the co-designed structure and work plan developed by these project partners. IPHI's supports for project coordination and analysis will serve to advance the overall engagement goals for the CIA:

- Environmental Equity Working Group (EEWG) co-designs the CIA for Chicago and is involved in all decision-making throughout the process.
- CDPH listens to, reflects on, and learns from community engagements in order to inform actionable plans for the CIA.

SUPPORT PROJECT LOGISTICS & COORDINATION

AUG. 2022 - JUNE 2023

- Attend coordination meetings with CDPH and other partners.
 Partner with CDPH and other partners on follow-up logistics and coordination.
- · Draft communications materials as needed.
- · Attend weekly CIA Project Management Team meetings.
- Manage and process payments for compensation to community-based project partners, based on the approach/amount determined between EEWG and CDPH.

BACKGROUND RESEARCH & LANDSCAPE ANALYSIS

AUG. - NOV. 2022

- Support CDPH with landscape analysis of other jurisdictions' engagement strategies – via document review and key informant interviews.
- Work with CDPH to integrate resources shared by EEWG and other environmental justice experts into the landscape analyses.
- Review draft reports and work together with CDPH to finalize reports and summarize material for presentation to EEWG and working groups.

ANALYSIS OF EXISTING COMMUNITY INPUT

JULY - SEPT. 2022

- Advise and provide analytic support to CDPH and EEWG for qualitative analysis of existing community input as identified by EEWG members.
- Work with CDPH and EEWG to identify: (a) recommendations and key findings from existing input that should be incorporated in the CIA process and (b) gaps in existing input that informs what additional input should be gathered directly in the CIA process.
- Support CDPH to work with EEWG, Tetra Tech, and other project partners to ensure integration of community data with other data sources/indicators within each phase and component of the CIA process.

DATA & METHODS WORKING GROUP

NOV. 2022 - MAY 2023

- Support co-chairs from CDPH and EEWG.
- Work with CDPH and EEWG and other project partners to scope assessment, develop methods and recommend data sources.
- Support CDPH to work with EEWG, Tetra Tech, and other project partners to ensure integration of community data with other data sources/indicators within each phase and component of the CIA process.

COMMUNICATIONS & ENGAGEMENT WORKING GROUP

NOV. 2022 - MAY 2023

- Support co-chairs from CDPH and EEWG.
- · Co-design activities including any engagement workshops.
- Coordinate meeting logistics, keep notes, and track follow-up actions from the working group meetings.
- As applicable, engage (and subcontract) with meeting facilitators.
- Determine with working group members the overall approach and work plan for documenting the CIA process, and execute upon tasks/roles for IPHI.
- Support CDPH to work with EEWG, Tetra Tech, and other project partners to ensure integration of community data with other data sources/indicators within each phase and component of the CIA process.
