Jennifer Vidis

Jennifer Vidis is Deputy Commissioner and Chief Program Officer at the Chicago Department of Public Health (CDPH), where she leads the development and implementation of strategy for improving maternal, infant, child and adolescent health outcomes with a focus on health equity and systems building. Under her leadership, CDPH is scaling a universal nurse home visiting program for families with newborns and expanding its programming in childhood lead poisoning prevention, reproductive health, school-based health services and nutrition. Prior roles include serving as a policy fellow at Chapin Hall and chief of schools at the Chicago Public Schools. Jennifer received her BA from Smith College and JD from Georgetown University.



Sharita Webb

Sharita Webb is the Director of Public Health Operations for the Lead Poisoning Prevention and Healthy Homes Program (LPPHH) for the Chicago Department of Public Health. She is responsible for programming oversight for the LPPHH program for the City of Chicago. This program encompasses nurse case management, environmental inspections, grant administration, community engagement and enforcement. The program has over 45 staff members.

Sharita has been a public servant for the City of Chicago for 25 years. She played a crucial role in securing an \$8.7 million dollar grant from the United States Department of Housing and Urban Development (HUD) and \$45.3 million Bond Funding from the City of Chicago.

These funds will benefit the constituents of the City of Chicago by abating lead hazards in their home and addressing other healthy homes hazards.

Sharita was born and raised on the southside of Chicago. She obtained her master's degree in education from Governors State University. She is a co-founder of the Wonderful Woman Wednesday Chicago community organization. She is a proud member of the Zeta Phi Beta Sorority Inc. Sharita was elected and served on the Morgan Park High School Local School Council for four years. Sharita has been married to her wonderful husband for 25 years. She and her husband have two amazing children and a loving dog name Rio Francisco.



Emile Jorgenson, MPH

Emile Jorgensen was trained in occupational and environmental epidemiology at the University of Illinois-Chicago School of Public Health. He received his MPH in 2005 and dropped out of the PhD program in 2010. He has worked in the Chicago Department of Public Health Lead Poisoning Prevention program since 2007.

His current role with CDPH Lead Department is to find the source of lead at the homes of children with an Elevated Blood-Lead Level (EBL)



Ajanta Patel MD MPH

Ajanta Patel MD MPH is Medical Director overseeing the Office of Chronic Disease Prevention and Health Promotion at the Chicago Department of Public Health. She oversees community health outreach programs, chronic disease epidemiology and policy, and Chicago-based partnerships designed to improve conditions that lead to chronic disease. Her key initiatives have included standing up CDPH's Community Health Worker program, expansion of the Tobacco Program with Menthol and Vaping funds, and initiation of data modernization efforts with Chicago's CAPriCORN data network.

Dr. Patel is a board certified pediatric pulmonologist and practices at La Rabida Children's Hospital in Chicago. Prior to joining CDPH, Dr. Patel was as an Assistant Professor of Pediatrics at The University

of Chicago and Medical Director of Informatics at University of Chicago Medical Center. She completed clinical residency and fellowship training at The University of Chicago. She is a graduate of Emory University School of Medicine and School of Public Health and holds a bachelor's degree from Amherst College.



Nick Peneff, DrPH

He is a board certified emergency physician on staff at Endeavor Health and a board certified medical toxicologist with toxicology consulting privileges at John H. Stroger Jr Hospital of Cook County.
