President Foreman called the meeting to order. He stated that he has determined that holding this meeting in person is not practical or prudent due to the COVID-19 pandemic, and that the meeting is therefore being held remotely to protect the public's health, as authorized by the Illinois Open Meetings Act. He noted that the meeting is open to the public via audio and video conference and is being carried live by CAN-TV.

Minutes of Previous Meetings

Vice President Wolff moved to approve the drafts of the minutes of the Board's public and closed meetings held on January 19 and February 16, 2023, that were circulated in advance of the meeting. The motion passed by a vote of 6 in favor (Foreman, Wolff, Block, Cusack, Doorley, and Montes) to 0 opposed.

Upcoming Meetings

President Foreman announced that the Board's next regular public meeting will be on Thursday, April 20, 2023, at 7:30pm.

Vice President Wolff moved to close a series of executive sessions of the Board for the purposes of considering personnel matters and litigation, as authorized by sections 2(c)(1), (4), (11), and (21) of the Illinois Open Meetings Act. The motion passed by a vote of 6 in favor (Foreman, Wolff, Block, Cusack, Doorley, and Montes) to 0 opposed. President Foreman noted that the minutes of the executive sessions are posted on the Board's website.

Update on the Search for a New Superintendent of Police

Commissioner Remel Terry provided an update on the search for a new Superintendent of Police being conducted by the Community Commission for Public Safety and Accountability. *(See the transcript and the video recording of the meeting, posted on the Board's website, for the complete presentation.)*

Police Disciplinary Matters

President Foreman reported that Board, as authorized by the Open Meetings Act, has considered in a closed meeting one disciplinary case and that the Board will take final action on this case:

- Case No. 22 PB 3002. President Foreman noted that the Superintendent filed charges against Police Officer Ernesto Guzman-Sanchez recommending that he be discharged from the Chicago Police Department for charges stemming from domestic incidents while off duty. President Foreman reported that the Superintendent and the accused officer have agreed to settle the case and have the officer serve a suspension without pay for a period of one year. Vice President Wolff moved to approve the settlement agreement and order a one-year suspension of Officer Guzman Sanchez. The motion passed by a vote of 6 in favor (Foreman, Wolff, Block, Cusack, Doorley, and Montes) to 0 opposed.

President Foreman noted that due to the COVID-19 pandemic, the Police Board has entered three general omnibus orders on conducting disciplinary hearings via two-way video-conferencing using Zoom. He reported that given declines in the number of COVID cases and Governor Pritzker's recent announcement that the State's public health emergency will formally end on May 11th, the Board has drafted a fourth general omnibus order, which has been posted on the Board's website along with the agenda for this meeting. Vice President Wolff moved to

approve this draft order. The motion passed by a vote of 6 in favor (Foreman, Wolff, Block, Cusack, Doorley, and Montes) to 0 opposed.

CPD Applicant Appeals

President Foreman reported that the Board, as authorized by the Open Meetings Act, considered in a closed meeting several appeals from applicants for a Chicago police officer position who have been removed from the eligibility list due to the results of a background examination, and he stated that the Board will now take final action on these appeals.

Vice President Wolff moved to adopt the appeals officer's findings, conclusions, and recommendation to affirm the decision to disqualify the applicant in Appeal Nos. 22 AA 06, 08, 09, 10, and 13, and to adopt the appeals officer's findings, conclusions, and recommendation to reverse the decision to disqualify the applicant in Appeal No. 22 AA 12. The motion passed by a vote of 6 in favor (Foreman, Wolff, Block, Cusack, Doorley, and Montes) to 0 opposed.

Superintendent's Report

Interim Superintendent Carter reported on several matters, including the death of Police Officer Andres Vasquez-Lasso, who was killed in the line of duty on March 1st, declines in homicides and shootings across the City, and recruitment and graduations of new police officers. *(See the transcript and the video recording of the meeting, posted on the Board's website, for the complete report.)*

Chief Administrator's Report

Chief Administrator Kersten reported on several matters, including complaints of alleged police misconduct received and investigations concluded by COPA, and COPA's People's Academy; she also spoke of the loss of Officer Vasquez-Lasso. *(See the transcript and the video recording of the meeting, posted on the Board's website, for the complete report.)*

Questions and Comments from the Public

President Foreman called upon the members of the public who signed up in advance to speak at the meeting. *(See the transcript and the video recording of the meeting, posted on the Board's website, for the complete remarks of each speaker and responses to speakers' questions and concerns.)*

- Dajae Allen, a member of the Youth Organized Until Trauma Heals Council, reported on the council's recent activities.
- President Foreman called upon the following individuals and there was no response: Crista Noel and Robert More.

President Foreman stated that all persons who had signed up in advance to speak had been called. Vice President Wolff moved to adjourn the meeting. The motion passed by a vote of 6 in favor (Foreman, Wolff, Block, Cusack, Doorley, and Montes) to 0 opposed.

He stated that he has determined that holding this meeting in person is not practical or prudent due to the COVID-19 pandemic, and that the meeting is therefore being held remotely to protect the public's health, as authorized by the Illinois Open Meetings Act. He noted that the meeting is open to the public via audio and video conference and is being carried live by CAN-TV.

President Foreman welcomed new Board Members Aja Carr-Favors and Andreas Safakas to their first meeting.

Upcoming Meetings

President Foreman announced that the Board's next regular public meeting will be on Thursday, May 18, 2023, at 7:30pm. He noted that the meeting will take place in person at Chicago Public Safety Headquarters, 3510 South Michigan Avenue.

Vice President Wolff moved to close a series of executive sessions of the Board for the purposes of considering personnel matters and litigation, as authorized by sections 2(c)(1), (4), (11), and (21) of the Illinois Open Meetings Act. The motion passed by a vote of 9 in favor (Foreman, Wolff, Block, Carr-Favors, Cusack, Doorley, Eaddy, Montes, and Safakas) to 0 opposed. President Foreman noted that the minutes of the executive sessions are posted on the Board's website.

Police Disciplinary Matters

President Foreman reported that Board, as authorized by the Open Meetings Act, has considered in a closed meeting three police disciplinary cases and that the Board will take final action on these cases:

- Case No. 21 PB 2998. Vice President Wolff moved to find Police Officer Jose Troche-Vargas guilty of engaging in two unjustified altercations and making a false report and to discharge him from the CPD. The motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed. Vice President Wolff moved to adopt the written findings and decision that have been reviewed by all Board members who participated in this case. The motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed.
- Case No. 22 PB 3001. President Foreman noted that there are three accused officers in this case:
 - Vice President Wolff moved to find Police Officer Chavez Siler guilty of using excessive force on an arrestee to suspend him without pay for a period of six (6) months. The motion passed by a vote of 6 in favor (Foreman, Wolff, Cusack, Doorley, Eaddy, and Montes) to 1 opposed (Block).
 - Vice President Wolff moved to find Police Officer Corey Boone not guilty of using excessive force, failing to report Officer Siler's use of excessive force, and making a false report, and to reinstate Officer Boone to his position with the CPD. The motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed.
 - Vice President Wolff moved to find Police Officer Robert Clark not guilty of failing to report Officer Siler's use of excessive force and making a false report, and to reinstate Officer Clark to his position with the CPD. The motion passed by

a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed.

- Vice President Wolff moved to adopt the written findings and decisions and dissent that have been reviewed by all Board members who participated in this case. The motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed.
- Case No. 23 PB 3021. President Foreman reported that the Superintendent filed charges against Police Officer Gianvernice Cabral-Rivera recommending that he be discharged from the CPD for engaging in sexual misconduct, and that the Superintendent subsequently moved to withdraw these charges without prejudice because Gianvernice Cabral-Rivera resigned from the CPD. Vice President Wolff moved grant the Superintendent's motion. Vice President Wolff's motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed.

CPD Applicant Appeals

President Foreman reported that the Board, as authorized by the Open Meetings Act, considered in a closed meeting several appeals from applicants for a Chicago police officer position who have been removed from the eligibility list due to the results of a background examination, and he stated that the Board will now take final action on these appeals.

Vice President Wolff moved to adopt the appeals officer's findings, conclusions, and recommendation to affirm the decision to disqualify the applicant in Appeal Nos. 22 AA 11, 14, and 16, and to adopt the appeals officer's findings, conclusions, and recommendation to reverse the decision to disqualify the applicant in Appeal Nos. 22 AA 07 and 15. The motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed.

Superintendent's Report

President Foreman thanked Interim Superintendent Carter for his more than 30 years of service on the CPD. Interim Superintendent Carter reported on several matters, including the recent gathering of teens downtown and CPD's plans to address crime downtown and in the neighborhoods during the summer. *(See the transcript and the video recording of the meeting, posted on the Board's website, for the complete report.)*

Chief Administrator's Report

Chief Administrator Kersten reported on several matters, including complaints of alleged police misconduct received and investigations concluded by COPA, COPA's video-release policy, and community engagement initiatives. *(See the transcript and the video recording of the meeting, posted on the Board's website, for the complete report.)*

Questions and Comments from the Public

President Foreman called upon the members of the public who signed up in advance to speak at the meeting. *(See the transcript and the video recording of the meeting, posted on the Board's website, for the complete remarks of each speaker and responses to speakers' questions and concerns.)*

1. General Business

- a. Executive Director Caproni noted that this meeting is taking place via video conference because President Foreman has determined that holding an in-person meeting is not practical or prudent due to the COVID-19 pandemic.
- b. Vice President Wolff moved to approve the draft of the minutes of the December 15 2022, executive session that was circulated prior to the meeting. The motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed.
- c. Executive Director Caproni made the following announcements:
 - i. President Foreman has submitted written goals for 2023 to the Community Commission for Public Safety and Accountability, as required by the Municipal code.
 - ii. At the upcoming public meeting there will be a report on the Board's compliance with the requirements of the Consent Decree.

2. Appeals from disqualified applicants to become a police officer

- a. **Appeal No. 22 AA 05, Brandon Pitts.** Appeals Officer Porter provided a summary of his written findings, conclusions, and recommendation that was circulated prior to the meeting. After due consideration, the Board took a preliminary vote and agreed to take final action on this case at an upcoming public meeting.

3. Police Disciplinary Cases

- a. **Case No. 22 PB 3010, Raul Alvarez.** Executive Director Caproni reported that the Superintendent moved to withdraw the charges without prejudice because the Respondent resigned his position with the Chicago Police Department. Executive Director Caproni noted that the motion is on the agenda for final action at the upcoming public meeting.
- b. **Case No. 22 PB 3006, Daniel Otero.** Special Assistant Corporation Counsel Bethany Biesenthal reported on Respondent's motion to dismiss the charges. After due consideration, Board Member Block moved to deny the motion. Board Member Block's motion passed by a vote of 7 in favor (Foreman, Wolff, Block, Cusack, Doorley, Eaddy, and Montes) to 0 opposed. The Board directed that a written memorandum and order be prepared and issued to the parties.

4. Matters related to pending litigation: Consent Decree entered in *Illinois v. Chicago*

- a. Paragraph No. 543: Executive Director Caproni reported that the City and the Illinois Attorney General filed with the U.S. District Court a Stipulation Regarding the Review and Comment Process for the Chicago Police Board's Adoption and Revision of Rules and Regulations for the Chicago Police Department.
- b. Paragraph Nos. 540 – 542: Executive Director Caproni provided an update on efforts to develop future training for Board members and hearing officers.

**Policy Regarding the Attendance of and Participation by
the Public at Board Meetings**

July 23, 2019

The Police Board values the attendance of the public at its meetings and the opportunity to receive comments and questions on matters concerning the Board or the Police Department. The Board will treat members of the public with courtesy and respect, and expects that the public will treat Board members and Department members in a similar manner.

Toward that end, the Board has adopted the following rules governing conduct at Board meetings:

1. An individual wishing to address the Board must sign-up in advance by contacting the Board's office no later than 3:00 p.m. of the day of the meeting, or by signing up in person at the meeting location up to 15 minutes before the meeting begins.
2. When called upon to address the Board, each speaker is to identify him/herself and speak clearly so that all in attendance may hear and so that the court reporter may make an accurate record of the proceedings.
3. Due to time constraints, each speaker is limited to two minutes and must conclude when asked to do so by the Board member acting as parliamentarian.
4. Personal attacks, obscene language, fighting words, threats, conduct intended to disrupt or interfere with the meeting, and comments not related to matters within the Board's or the Department's jurisdiction, by a speaker or any person in attendance, are strictly prohibited.

Violation of any of the above rules may result in the removal of the violator from the meeting room, or in the immediate adjournment of the meeting; in addition, repeated violations may result in the violator not being permitted to attend or participate in future Board meetings.

Policy Regarding Community Input Received at Police Board Public Meetings¹ June 20, 2019

The City values the attendance of the public at monthly Police Board meetings and the opportunity to receive comments and questions concerning police-related matters. The following policy is created to ensure responsiveness to community input received at the meetings.

1. Each Police Board public meeting shall be transcribed by a court reporter. The transcript of the meeting shall include a complete report of each speaker's remarks, and shall be posted on the Police Board website.
2. Within seven business days of the public meeting, the Executive Director of the Police Board shall review the transcript of the meeting, classify the community input received, and direct the community input to the appropriate responding agency (Police Department, Civilian Office of Police Accountability, Police Board, Deputy Inspector General for Public Safety, and/or any other appropriate agency).
3. Each responding agency shall make best efforts² to respond fully to the community input.
4. Within ten business days of receiving the community input from the Executive Director of the Police Board, each responding agency shall provide the Executive Director with a written report documenting its response to the community input to date. The Executive Director of the Police Board shall track all community input and responses.
5. The Executive Director of the Police Board shall post on the Police Board website prior to the next public meeting: (a) a report of the tracking of community input and responses (if no response is received, this will be noted on the report), and (b) each responding agency's written report of its response to the community input.

¹ This policy is created to fulfill the requirements of Paragraph No. 538 of the Consent Decree entered in Illinois v. Chicago:

538. Within 90 days of the Effective Date, the City will create a policy for collecting, documenting, classifying, tracking, and responding to community input received during the Police Board's regular community meetings. The policy will outline the methods for: (a) directing community input to the appropriate responding entity, agency, or office; and (b) documenting and making public, all responses to community input.

² As defined in Paragraph No. 729 of the Consent Decree, "Best efforts' require a party, in good faith, to take all reasonable steps to achieve the stated objective." (Footnote added on October 18, 2019)
