MINUTES [Draft]

Board Members Present: President Demetrius E. Carney, Vice President Ghian Foreman, Melissa M. Ballate, William F. Conlon, Michael Eaddy, Rita A. Fry, Elisa Rodriguez, and Rhoda D. Sweeney.

Board Members Absent: None.

Others Present: First Deputy Superintendent of Police Alfonza Wysinger, General Counsel to the Superintendent Ralph Price, Independent Police Review Authority Chief Administrator Scott M. Ando, Police Board Executive Director Max A. Caproni, and members of the public.

President Carney called the meeting to order.

1. Vice President Foreman moved to approve the minutes of the Board's public meeting of May 21, 2015. The motion passed by a unanimous vote.
2. President Carney announced that the Board's next public meeting will be at 7:30 p.m. on Thursday, July 16, 2015, at Chicago Public Safety Headquarters. Vice President Foreman moved to close a series of executive sessions of the Board for the purposes of considering litigation and personnel matters, as authorized by sections 2(c)(1), (3), (4), and (11) of the Illinois Open Meetings Act. The motion passed by a unanimous vote.
3. President Carney stated that a report of disciplinary actions taken by the Board during the previous month has been made available at the meeting and on the Board's website, and he noted that the Board's written findings and decisions are posted on the website.
4. President Carney announced that copies of orders issued by the Superintendent of Police during the previous month are listed in the blue books made available at the meeting and are available on the Police Department's website.

5. President Carney noted that the next item of business is the Superintendent's report. Vice President Foreman moved that the oral presentation be waived and that the report be received in writing. The motion passed by a unanimous vote.

6. President Carney called upon those members of the public who had signed up in advance to speak (*see the transcript of the meeting, posted on the Board's website, for a complete report of the discussion*).

- Kevin Ammons offered suggestions to reduce crime in the community.
- Larone Ellison, Crista Noel, LaCreshia Birts, and Grace Mattingly spoke on the fatal shooting of Rekia Boyd by Detective Dante Servin while off duty. Chief Administrator Ando, First Deputy Superintendent Wysinger, and several Board members responded to the comments.
- Rachel Williams spoke about the complaint of alleged misconduct her mother filed with the Independent Police Review Authority.
- President Carney called upon Chelsea Sprengeler and there was no response.

President Carney stated that all persons that had signed up in advance to speak had been called and that the meeting was adjourned.

**Policy Regarding the Attendance of and Participation by
the Public at Board Meetings**

(Adopted 15 December 2005)

The Police Board values the attendance of the public at its meetings and the opportunity to receive comments and questions on matters concerning the Board or the Police Department. The Board will treat members of the public with courtesy and respect, and expects that the public will treat Board members and Department members in a similar manner.

Toward that end, the Board has adopted the following rules governing conduct at Board meetings:

1. An individual wishing to address the Board must sign-up in advance by contacting the Board's office by phone, fax, or in person no later than 4:30 p.m. of the day before the meeting.
2. When called upon to address the Board, each speaker is to identify him/herself and speak clearly so that all in attendance may hear and so that the court reporter may make an accurate record of the proceedings.
3. Due to time constraints, each speaker is limited to two minutes and must conclude when asked to do so by the Board member acting as parliamentarian.
4. Personal attacks, obscene language, fighting words, threats, conduct intended to disrupt or interfere with the meeting, and comments not related to matters within the Board's or the Department's jurisdiction, by a speaker or any person in attendance, are strictly prohibited.

Violation of any of the above rules may result in the removal of the violator from the meeting room, or in the immediate adjournment of the meeting; in addition, repeated violations may result in the violator not being permitted to attend or participate in future Board meetings.

PERSONNEL AND TRAINING

During the month of **June 2015**, **114** training blocks were conducted for Chicago Police Recruits, Metropolitan Recruits (including surrounding agencies) and In-Service Courses.

A total of **5,158** Department attendees received In-Service/E-Learning training, which included: Patrol Carbine Operator Course and Requalification, Law Enforcement Protective Measures, Gang Violence Reduction Strategy, Procedural Justice 1 and 2, Taser Qualification and Recertification, Automated Contact Card User Guide, Domestic Violence 4-Part Refresher, Firearms Concealed Carry Act Online Course, Contact Information System, First Amendment Online Training, Crowd Control Online Review, Hate Crime Online Training (ADL) – 3 Part Program, Hazmat Annual Refresher, Pedestrian Safety, Occupational Exposure to Disease Refresher, Vehicle Pursuits and Balancing Test, Use of Force Policy, Meth Awareness 4-Part Program.

A total of **264** Chicago Police Recruits were in training along with **9** Metropolitan Police Recruits.

Crisis Intervention Training (CIT) [*YTD as of 14 Jul 2015*]:

1,857 Active CIT certified personnel

232 individuals trained in Basic CIT (178 CPD members and 54 outside agencies)

127 individuals trained in Advanced CIT for Youth (111 CPD members and 16 outside agencies)

24 Lieutenants, **31** Sergeants and **267** recruits completed Mental Health training (4 hours)
