REPORT OF COMMUNITY INPUT RECEIVED AT THE PUBLIC MEETING ON NOVEMBER 19, 2020 Date of Report: December 17, 2020

CeCe Edwards., GCPAC, Inc. President (Community Concerns 006th District and Youth intervention)

 Officer Michaelene Rosa reached out via email as we did not have a phone number for Ms. Edwards. Ms. Edwards emailed her number and our office is currently waiting for a call back from Ms. Edwards. Ms. Edward related via email her organization would like to work with CPD to find activities for neighborhood youth. Office of Operations will refer Ms. Edwards to the Community Relations Office, Commander Angel Novalez and contact information for 06th District CAPS.

Jennifer Edwards, Jessie Pollard, and Eunice Chatman-Regis (Community Concerns 006th District)

- Our office has been in contact with all three community members.
- All members expressed they are very happy with the 006th District Commander and CAPS personnel.
- Office of Operations forwarded the locations of concern to the Commander of 006th District.
- There is a special attention on Beats 623 and 624.
- Tact Team has been monitoring activity at the 419-457 block of east 79th street and 77th to 82nd State to Cottage Grove. Officers will continue to monitor the area.
- Officer Rosa has been in contact with Ms. Edwards of Communities Organized to Win. Ms. Edwards related she participates in CAPS Meeting in the 006th, 003rd and 004th District. Ms. Edwards and her organization will continue to work in partnership with the Chicago police Department.
- Ms. Pollard and Ms. Chapman-Regis are pleased to hear of the special attention in their locations of concern.
- Ms. Pollard called on 15 Dec 2020 with questions regarding alternatives for the young people hanging out/loitering by the gas stations and stores. She was put in contact with the Community Relations Office here at PSHQ for follow up.

Mr. Perryman (011th District and Garfield Park Homeless Campsite and Narcotics)

- Deputy Chief Cato and Commander Spencer continue to be in contact with Mr. Perryman to address his concerns and ensure there is a safe community for all.
- Deputy Chief Cato has coordinated with Deputy Chief Mills and has had a narcotics team assigned to Garfield Park.
- Deputy Chief Barz is providing a Community Safety Team car to Garfield Park.
- 011th District CAPS officers have coordinated walks through the park with community members.
- As of this date the Deputy Chief related there are no homeless campsites.
