at the Office of Chicago Public Safety at 35th and Michigan on February 19th at 7:30. At this time, I would ask the motion to close a series of executive sessions for the purposes of considering litigation and personnel matters as authorized by the Open Meetings Act. Is there a motion?

Board members 17 18 Foreman and Eaddy are opposed. The motion passes. 19 Is there a motion to adopt the written findings and 20 decisions and dissent that has been reviewed by all Board members who participated in the case? 21 22 MS.
