1 PRESIDENT FOREMAN: Good evening. My name
2 is Ghian Foreman. I am president of the
3 Chicago Police Board, and I am calling the
4 Board's May 21st public meeting to order.

5 To protect the public's health in
6 response to the COVID-19 outbreak and as
7 permitted by Governor Pritzker's executive
8 orders 2020-07 and 2020-33, this meeting is
9 taking place via audio conference. This
10 conference call is open to the public. Those
11 participating by phone are on mute in order to
12 reduce background noise and disruption. We
13 have a court reporter making a transcript of
14 this meeting.

15 I will begin by taking attendance
16 so we know who is participating in this
17 meeting. If you are on the call, please say
18 "here" after I read your name. Police Board
19 Vice President Paula Wolff.

20 BOARD MEMBER WOLFF: Here.

21 PRESIDENT FOREMAN: Board member Matthew
22 Crowl.

23 BOARD MEMBER CROWL: Here.

24 PRESIDENT FOREMAN: Board member Michael

1 Eaddy.

2 BOARD MEMBER EADDY: Here.

3 PRESIDENT FOREMAN: Board member Steve

5 BOARD MEMBER FLORES: Here.

8 BOARD MEMBER MONTES: Here.

20 SUPERINTENDENT BROWN: Here.

21 PRESIDENT FOREMAN: General counsel for the
22 Superintendent Dana O'Malley.

23 MS. O'MALLEY: Here.

24 PRESIDENT FOREMAN: Chief Administrator of

1 the Civilian Office of Police Accountability
2 Sidney Roberts.

3 MS. ROBERTS: Here.

4 PRESIDENT FOREMAN: And, pardon me, Tina
5 Skahill, because I don't know what your title
6 is. We have Tina Skahill from the Internal
7 Affairs, but I apologize, I don't know your
8 title.

9 Acting Deputy Inspector General
10 for Public Safety Deborah Witzburg.

11 MS. WITZBURG: Here.

12 PRESIDENT FOREMAN: Executive Director of
13 the Police Board Max Caproni.

14 MR. CAPRONI: Here.

15 PRESIDENT FOREMAN: And Tina Skahill is
16 Deputy Director of Internal Affairs. Thank
17 you.

18 We will now proceed to the items
19 on the meeting agenda. We have time at the end
20 of the meeting for public comments. Once
21 again, those participating by phone are
22 currently on mute in order to reduce background
23 noise and disruption. When we get to the
24 public comment portion of the meeting, we will

1 unmute each speaker.

2 Is there a motion to approve the
3 minutes of the Board's April 1st special public
4 meeting and the April 16th regular public
5 meeting?

6 BOARD MEMBER WOLFF: This is Paula Wolff.
7 I move the motion.

8 BOARD MEMBER EADDY: This is Michael Eaddy.
9 I second.

10 PRESIDENT FOREMAN: All in favor, please
11 say aye.

12 (CHORUS OF AYES.)

13 PRESIDENT FOREMAN: Any opposed? Any
14 abstentions?

15 (NO RESPONSE.)

16 PRESIDENT FOREMAN: Thank you. Next
17 regular public meeting will be held Thursday,
18 June 18th at 7:30 p.m. Whether this will be an
19 in-person meeting or conference will be
20 determined closer to the meeting date.

21 Is there a motion to -- can
22 someone mute their phone?

23 Is there a motion to close a
24 series of executive sessions for the purposes

1 of considering personnel matters in litigation
2 as authorized by Sections 2(c)(1), (3), (4) and
3 (11) of the Illinois Open Meetings Act?

4 BOARD MEMBER WOLFF: This is Paula Wolff
5 again. I so move.

6 BOARD MEMBER EADDY: Michael Eaddy. I
7 second.

8 PRESIDENT FOREMAN: Thank you. All in
9 favor please say aye.

10 (CHORUS OF AYES.)

11 PRESIDENT FOREMAN: Any opposed? Any
12 abstentions?

13 (NO RESPONSE.)

14 PRESIDENT FOREMAN: Motion passes
15 unanimously.

16 A report of disciplinary action
17 taken by the Board during the previous month
18 had been made available on the Board's website.

19 The Police Board plans to
20 consider at a future public meeting several
21 proposed amendments to its rules of procedure.
22 Drafts of these proposed amendments are posted
23 in the alert section of the Board's website at
24 ChicagoPoliceBoard.org. The Board welcomes

1 public comments on the proposed amendments.

2 Comments are due by June 8th. Please see the
3 website for additional information.

4 The general orders and other
5 directives issued by the Superintendent during
6 the previous month are posted on the Police
7 Department's website.

8 I will now ask the Superintendent
9 to give an oral report.

10 SUPERINTENDENT BROWN: Sure. And thank
11 you so much for the time, Ghian. Board, thank
12 you so much, Police Board, for giving me the
13 opportunity to address you again.

14 Again, I'm a month into the job,
15 just a couple of days ago.

16 PRESIDENT FOREMAN: As a matter of fact,
17 I'm sorry, I'm going to interrupt for one
18 second. I'm going to take the opportunity to
19 interrupt and officially thank you. We had you
20 last month, which you were an interim position,
21 and now it is official. So on behalf of the
22 Police Board and citizens of Chicago, we would
23 like to officially welcome you. It's a tough
24 job. We know that you are up for the job. And

1 we're looking forward to seeing what your
2 leadership brings to the City.

3 So I apologize for the
4 interruption, but I couldn't let that go
5 without saying something.

6 SUPERINTENDENT BROWN: Thank you, again,
7 so much for the welcome. It's been quite a
8 welcome. And I hit the ground running. It's
9 been quite a welcome with the pace, but I feel
10 very confident that this fine department will
11 prove itself something to be proud of through
12 its reform by meeting the standards of the
13 Consent Decree. We're well on our way to
14 improving meeting the deadlines.

15 Next, we obviously have quite a
16 challenge with addressing violent crime in the
17 City. We've made some bold statements
18 regarding a moonshot goal of having historical
19 lows in violent crime in this City. I believe
20 we have the collaboration and support and the
21 talent, but we have to believe we can first and
22 then we push all of our efforts and resources
23 toward achieving a moonshot goal of reducing
24 violent crime in the City to historical lows.

1 I started out with obviously
2 visiting the districts during my first 30 days.
3 I've done the mills to seniors in some of my
4 more challenging areas. I think it's quite
5 timely that we take the initiative of the
6 Superintendent's position into the communities
7 that have the greatest need and show compassion
8 and empathy and not be only seen as a prime
9 enforcement. We should be community oriented
10 in our policing and collaborative and what
11 better way than to show compassion toward our
12 seniors by delivering meals through some of the
13 great nonprofit efforts.

14 Next, you'll see this pretty
15 soon. I just want to give you a little bit of
16 a glimpse. I'm in training with an NBA 2-K
17 gaming system right now, because I know nothing
18 about gaming, and I'm going to challenge -- a
19 shoot challenge to one of the young people on
20 our west and south sides to NBA 2-K games,
21 because we can't actually shoot hoops because
22 of COVID-19. So stay tuned for that. And some
23 of you might want to brush up. I might
24 challenge some of you Police Board members,

1 too, so get your grandkids and cousins to train
2 you up on NBA 2-K.

3 Next, I really want to convey
4 this idea of reform. It is really important to
5 me that we have not only the perceptions that
6 we are meeting the standards of the Consent
7 Decree, but the Consent Decree status being a
8 floor, not a ceiling; that we really want to
9 exceed what the Consent Decree requires.

10 We think Chicagoans can only
11 trust us if we are seen as not only agreeing to
12 what's required but exceeding, showing the true
13 spirit of the Consent Decree. And so that's
14 going to be a passion of mine.

15 We're working to create an
16 accountability process, so weekly reviews of
17 our progress, rather than waiting until the
18 next six months of report from the monitor.

19 And I met the monitor. Maggie
20 and I hit it off. We are on the same page.
21 We're moving forward with input and feedback on
22 a constant basis.

23 We're also looking at other
24 collaborations with our outreach community.

1 That's really important that you have such
2 large commitment from not only funding that the
3 mayor and other nonprofits and philanthropists
4 have put forward in our outreach groups, but
5 you have this, I think, stirring of the pot.
6 There's a sense that we're ready to roll the
7 ball forward and be even more integrated
8 between our police officers, our districts in
9 our areas and what the influencers can bring to
10 tapping down the violence that happens way too
11 often on an unacceptable level.

12 So there's a lot of moving parts
13 happening. I'm so excited about the
14 opportunity the City has given me and the Mayor
15 has given me, and I want to continue to express
16 my gratitude toward this Board and the
17 confidence you've shown in me. And I won't let
18 you down. I won't. I'll keep my promises, and
19 I'll give you everything I have to ensure
20 Chicago is the safest city in the country and
21 this Department is seen as one of the best
22 departments in the country, bar none.

23 So with that, before I leave, I
24 want to make sure that Dana, my general

1 counsel, can advise me, did I miss anything? I
2 know there were some points I wanted to make.

3 By the way, I always have my
4 lawyer with me on almost every decision because
5 of my previous experience. It's better to have
6 a lawyer in the room at the beginning than to
7 figure out a way how to get out of something
8 you've done in hindsight. Dana is a critical
9 partner with me in all of my efforts to move
10 the ball up the hill here in Chicago. So,
11 Dana, did I miss anything?

12 MS. O'MALLEY: No, sir, you covered all
13 your points.

14 SUPERINTENDENT BROWN: Thank you. Back to
15 you, Ghian.

16 PRESIDENT FOREMAN: Thank you very much,
17 Superintendent. I will now move to final
18 action. The Police Board as authorized by The
19 Open Meetings Act has considered in closed
20 meetings two disciplinary cases. The Board
21 will now take final action on these cases.
22 Regarding case number 19PB2963, is there a
23 motion to find Police Officer Edward Kropp
24 guilty of engaging in an unjustified

1 altercation while off duty and making false
2 statements and to discharge him from the
3 Chicago Police Department?

4 BOARD MEMBER WOLFF: This is Paula Wolff
5 again. So moved.

6 BOARD MEMBER EADDY: Michael Eaddy.
7 Second.

8 PRESIDENT FOREMAN: I will now call on
9 members of the Board for their vote. Wolff.

10 BOARD MEMBER WOLF: Aye.

11 PRESIDENT FOREMAN: Crowl.

12 BOARD MEMBER CROWL: Aye.

13 PRESIDENT FOREMAN: Eaddy.

14 BOARD MEMBER EADDY: Aye.

15 PRESIDENT FOREMAN: Flores.

16 BOARD MEMBER FLORES: Aye.

17 PRESIDENT FOREMAN: Montes.

18 BOARD MEMBER MONTES: Aye.

19 PRESIDENT FOREMAN: O'Malley.

20 BOARD MEMBER O'MALLEY: Aye.

21 PRESIDENT FOREMAN: Sweeney.

22 BOARD MEMBER SWEENEY: Aye.

23 PRESIDENT FOREMAN: Zopp.

24 BOARD MEMBER ZOPP: Aye.

1 PRESIDENT FOREMAN: And I also vote in
2 favor of the motion. Voting in favor are Board
3 Members Wolff, Crawl, Eaddy, Flores, Montes,
4 O'Malley, Sweeney, Zopp and myself. The motion
5 passes.

6 Is there a motion to adopt the
7 written findings and decision that have been
8 reviewed by all Board members who participated
9 in the case?

10 BOARD MEMBER WOLFF: This is Paula Wolff.
11 So moved.

12 BOARD MEMBER EADDY: Michael Eaddy.
13 Second.

14 PRESIDENT FOREMAN: All in favor?

15 (CHORUS OF AYES.)

16 PRESIDENT FOREMAN: Are there any opposed?

17 (NO RESPONSE.)

18 PRESIDENT FOREMAN: The motion passes.

19 Regarding case number 19PB2961,
20 the Superintendent filed charges against
21 Sergeant David DeMato recommending that he be
22 discharged from the Chicago Police Department
23 for using his official position for personal
24 gain and making a false statement. The

1 Superintendent subsequently moved to withdraw
2 these charges because the respondent resigned
3 his position with CPD.

4 Is there a motion to grant the
5 Superintendent's motion?

6 BOARD MEMBER WOLFF: Paula Wolff. So
7 moved.

8 BOARD MEMBER EADDY: Michael Eaddy.
9 Second.

10 PRESIDENT FOREMAN: I will now call on
11 members of the Board for their votes. Wolff.

12 BOARD MEMBER WOLFF: Aye.

13 PRESIDENT FOREMAN: Crawl.

14 BOARD MEMBER CROWL: Aye.

15 PRESIDENT FOREMAN: Eaddy.

16 BOARD MEMBER EADDY: Aye.

17 PRESIDENT FOREMAN: Flores.

18 BOARD MEMBER FLORES: Aye.

19 PRESIDENT FOREMAN: Montes.

20 BOARD MEMBER MONTES: Aye.

21 PRESIDENT FOREMAN: O'Malley.

22 BOARD MEMBER O'MALLEY: Aye.

23 PRESIDENT FOREMAN: Sweeney.

24 BOARD MEMBER SWEENEY: Aye.

1 PRESIDENT FOREMAN: Zopp.

2 BOARD MEMBER ZOPP: Aye.

3 PRESIDENT FOREMAN: And I vote in favor of
4 the motion. Voting in favor are Board members
5 Wolff, Crowl, Eaddy, Flores, Montes, O'Malley,
6 Sweeney, Zopp, and myself. The motion passes.

7 The decisions in the cases on
8 which the Board took final action this evening
9 will be entered as of today's date and issued
10 to the parties and will be posted on the
11 Board's website.

12 I will now call on members of the
13 public who signed up in advance to speak. Each
14 speaker will be unmuted after I call his or her
15 name. The first speaker is Jennifer Edwards.

16 MS. EDWARDS: Yes, good evening, everyone.

17 PRESIDENT FOREMAN: Good evening.

18 MS. EDWARDS: I'm not sure if you got my
19 copy in time, but I will read it. I doubt it
20 because I just sent it to Ghian.

21 We have your systems and
22 occurrences that are happening in our
23 neighborhoods on the south side with COVID
24 house parties. We've taken a proactive

1 approach by working with our police districts,
2 6th and 3rd Districts, to remedy the situation.
3 We also report this because numerous 911 calls
4 have either resulted in no police cars showing
5 or delayed police report.

6 We mention this not to complain
7 but to call attention to the need for more
8 police officers to be assigned to our area.

9 We ask that you consider
10 resolving the thin line between arrest and
11 dispersing of party participants since we are
12 hearing that not much can be done to prevent
13 future occurrences outside of surveillance.

14 We ask if this current of giving
15 citations and fines are police procedure and if
16 that can be implemented.

17 Our block club, Michigan-Indiana
18 Community Association, takes these situations
19 seriously. We are a long-standing, stable
20 community in the Park Manor-Chatham
21 neighborhood of primarily seniors living in the
22 area for 50 plus years who are concerned about
23 the COVID virus infection rate in our area.
24 We've been assigned a tactical detail, but not

1 sure if the situations will be preventable
2 without further escalation of the situation.

3 Cleanliness is also a problem
4 from the trash left on the street after the
5 parties.

6 The party of 5/13 also included a
7 man on a horse walking up and down the street
8 and on the lawn. This is the same person noted
9 on the recent Blocks of Chicago article, Riding
10 a Pinto. I've included a website for that.
11 The following steps were taken by the Block
12 Club Association regarding reoccurring parties
13 at the address. We also write this letter
14 because we've heard from recent conference
15 calls, CAPS meetings that parties are numerous
16 on the south side of Chicago.

17 PRESIDENT FOREMAN: Okay. I'm going to
18 stop you. I know Ms. Norfleet is next, so I'll
19 roll right into it. Next speaker is June
20 Norfleet.

21 MS. NORFLEET: Well, thank you. Chairman,
22 on this occasion we do not have continuous
23 read, so I do encourage the Board to review
24 neighbor Edwards' statement.

1 My statement is in defense of the
2 public good. We ask that the Chicago Police
3 and public safety work for the following
4 targets during what is a good lull in public
5 disorder and crime. We ask that you ramp up
6 your investigative divisions to gain
7 information and organize and gain activity so
8 that we can be in front of the parade and
9 report how and when this elevated action has
10 been achieved.

11 We further ask that you ramp up
12 community policing public safety campaigns.
13 Every officer should have at least five
14 grass-root contacts that they can regularly
15 count on and contact, if they are doing
16 grass-root community policing. We ask that the
17 Department provide training so that can become
18 a reality.

19 We further ask that they become
20 more visible in proactive training for the
21 general public to respond to public crisis,
22 whether it is a natural disaster or a
23 human-generated situation.

24 We ask that CPD and OEMC and

1 other relevant agencies should be about the
2 process of coalescing now to provide training
3 for the public. And we also ask that during
4 this downtime, that the CPD do internal
5 assessment, house cleaning, assessing officers
6 who want to work for the public good as opposed
7 to organizing and unions that are set out
8 against the public good that CPD is supposed to
9 be about.

10 We do this -- we ask that you do
11 this work so that we can enjoy the 30-percent
12 decrease in criminal activities that we have
13 seen recently.

14 We have enjoyed the fact that
15 instead of the screams of the sirens, they have
16 been replaced by the chirping of birds and
17 scampering of squirrels and the rustling of
18 leaves.

19 We ask that you do this granular
20 work while there is a void, knowing that nature
21 abhors a void, so fill it with good work.

22 PRESIDENT FOREMAN: Thank you.

23 MS. NORFLEET: Therefore we ask, What have
24 you done and what will you do in support of

1 Neighbor Edwards' question? Has the Chicago
2 Police left us alone while others violate our
3 public health?

4 Thank you so much. I believe
5 that some of my requests echo that of
6 Superintendent Brown, and we invite him
7 whole-heartedly to come and join and meet with
8 us here on the south side with some of our
9 local groups and we look forward to that.

10 We also look forward to seeing
11 some Board members come out. And with that,
12 Ghian Foreman, I release my time.

13 PRESIDENT FOREMAN: Thank you. Next
14 speaker is Matt Brandon.

15 MR. BRANDON: Good evening, President
16 Foreman, Vice President Wolff, Superintendent
17 Brown, General Counsel O'Malley and Members of
18 the Board: Communities Organized to Win, the
19 acronym COW, comes to express deep concern over
20 processed views to select the use-of-force
21 working group.

22 In a letter from one of the
23 cochairs to a citizen recruiter for this group,
24 it stated and I quote, "It is critically

1 important that people who lived experiences are
2 well referenced on this working group, so that
3 the CPD policy is informed by people of the
4 community that has been most impacted by CPD
5 violence and racism." The letter goes on to
6 say, "Most of you have lived experiences of the
7 impact of racial inequality, as well as
8 institutional racism within the Chicago Police
9 Department."

10 Recognizing that there are
11 problem officers within the ranks of CPD, it
12 must also be made clear that there are
13 thousands of CPD officers who risk their lives
14 in our communities every day with positive
15 outcomes.

16 It is important to ensure that
17 the good men and women of CPD have voices from
18 positive police interaction be a part of this
19 group.

20 Communities Organized to Win is
21 in the process of convening a Zoom conference
22 call with various community group leaders on
23 the south side who partnered to promote
24 positive interaction between community and

1 police.

2 The purpose of this call is to
3 offer Superintendent Brown reform, for
4 introduction and discussion with these
5 community partners.

6 We will provide an agenda at
7 least one week before and provide a list of the
8 community partners who will participate on the
9 call.

10 If Superintendent Brown is
11 amenable to this request, please provide at
12 least three dates and times of availability.
13 Our contact info is being forwarded to the
14 Office of the Superintendent.

15 Thank you and I hope the men and
16 women of the Chicago Police Department stay
17 safe.

18 PRESIDENT FOREMAN: Thank you, Mr. Brandon.
19 Next speaker is John Perryman.

20 MR. PERRYMAN: Hi. Good evening,
21 Superintendent, Police Board. I'm calling
22 today about a specific problem. I'm in the
23 11th District, and we have a park, Garfield
24 Park. It's our largest park on the west side.

1 We're having problems. The whole north end is
2 unusable. It's filled with needles from drugs
3 and there's a massive drug market at Lake and
4 St. Louis.

5 Now, I did reach out to the
6 Commander's Office two and a half weeks ago and
7 no one got back to me. I reached out a week
8 and a half ago, still no response.

9 This is a big problem. We need
10 open space. We need distance. But it's a
11 mess. Over on Walnut there's several drug
12 houses. The citizens on Walnut are very upset
13 that their block is becoming unlivable.
14 There's a drug crew rolling about 10, 15 people
15 deep, it's flagrant, it's open, and the
16 Commander knows about it.

17 So I have a couple of questions
18 for you, Superintendent. I need a couple of
19 things. First of all, can you have the
20 Commander give the community his strategy for
21 keeping -- the current strategy for keeping the
22 park safe for the community? Superintendent?

23 PRESIDENT FOREMAN: Mr. Perryman, why don't
24 ask you a couple of questions and then we'll

1 let the Superintendent respond.

2 MR. PERRYMAN: Okay. That's fine. Another
3 thing is, I'm asking if he will personally sit
4 down with community members who are very upset
5 about this? Please do not send the Commander.
6 The Commander had his chance. He can come with
7 you. But I'd let him know that I would -- I'd
8 let his office know, he does not seem to be
9 concerned about doing his work, so his chance
10 to take care of this -- so we need someone from
11 downtown to be there.

12 And also we need the Commander of
13 the 11th, that's Spencer, to come to the next
14 Board meeting to talk on the record about the
15 strategies in the park.

16 And most importantly, this is a
17 huge problem and we need a squad car on that
18 corner, this is Lake and St. Louis, staying
19 there 24/7. I know that's a big commitment,
20 but the issue is that this is a huge deal and
21 it's taken over this whole area. And it's
22 made, you know, a third of our park unusable.
23 And so we need a squad car on that.

24 If you guys would have taken care

1 of this earlier, we wouldn't need such a big
2 commitment. So can you respond on that,
3 Superintendent?

4 PRESIDENT FOREMAN: So, Superintendent, the
5 question is, one, Mr. Perryman and his
6 neighbors would like to get an understanding of
7 the current strategy relating to the park.
8 They would like to request a meeting with you
9 with the community. And third, specific
10 request regarding Lake and St. Louis. If you
11 would like to respond.

12 SUPERINTENDENT BROWN: Sure. Yes. Thank
13 you so much for your comments today. I have
14 driven the 11th District. I'm well aware of
15 some of the issues you brought. I would be
16 happy to meet. I would love to get an
17 opportunity to -- if we can do a Zoom call or a
18 conference call or as soon as the restrictions
19 are lifted meet all of you. And I'm also
20 willing to maybe do, you know, enough of social
21 distance in an area or room in the interim, if
22 we can't do Zoom, and bring the Commander with
23 me.

24 We do have new strategies that I

1 brought that I would love to share with you
2 regarding your area specifically to address
3 those specific concerns you raise. Without
4 giving away too much of what we plan to do,
5 let's talk off-line if you don't mind. Some of
6 it is very sensitive that we won't be able to
7 share with you, but we can share most of it
8 with you. I think you'll be well pleased. I
9 can look at leaving a car there, given that 911
10 call demand, but that's something I can be very
11 flexible with -- with you in regards to leaving
12 the car on the block where you have a
13 significant concern. And, again, I'm a
14 listening ear. I look forward to being able to
15 work with you over time. There's no easy
16 button on any of this. But we can collaborate
17 and work together and get some progress and get
18 you all feeling better about our response.

19 MR. PERRYMAN: Thank you, Superintendent.
20 I appreciate it. Can we meet very soon?
21 Because this problem is urgent. And until we
22 do have a meeting, can we get a car on that
23 corner?

24 PRESIDENT FOREMAN: Mr. Perryman, I will

1 make sure you get connected with the
2 Superintendent's Office.

3 Superintendent, if you can check
4 with the Commander to make sure that we can
5 take a look at Lake and St. Louis right away,
6 that would be greatly appreciated. Thank you.

7 Next speaker is David Sutherland.

8 MR. SUTHERLAND: Hello. Good evening.
9 Hello. I come to you today as a representative
10 of a group called Northwest Side Coalition
11 Against Racism and Hate.

12 In the few years that we've been
13 active, we've encountered issues with the
14 Chicago Police Department that we would like to
15 address at this time. I'll try to make this
16 brief. Number one: We have attended several
17 community policing strategic planning meetings
18 hosted by the local 16th District Police
19 Department. Unfortunately, every time the end
20 result was the same; community feedback ignored
21 or insolent and the idea of the Consent Decree
22 was dismissed.

23 We hope that this attitude isn't
24 indicative of CPD at large and that the Consent

1 Decree is viewed as a genuine effort of reform
2 going forward.

3 Number two: We ask that CPD
4 officially acknowledge Juneteenth, the oldest
5 nationally celebrated commemoration of the
6 ending of slavery in the United States.

7 Last year, the 16th District,
8 along with several local aldermen, sponsored a
9 Support Your Local Police rally on Juneteenth.
10 Even after being politely asked to move their
11 event to any other day to respectfully
12 commemorate Juneteenth, they refused.

13 Juneteenth is an official State
14 of Illinois holiday and hopefully will be
15 officially recognized by the City of Chicago,
16 but now is the time for CPD to treat this day
17 with the honor and sensitivity it deserves.

18 Number three is COVID related.
19 The use of police to encourage compliance to
20 the governor's stay-at-home order is a poor
21 public health approach.

22 This is particularly true given
23 the disparate policing of communities according
24 to racial makeup.

1 We believe officers of the 16th
2 District and across the City were involved in
3 so-called surge missions to disproportionately
4 police black communities while ignoring the
5 exact same behavior in the white communities.

6 This form of racial terrorism
7 cannot be tolerated or justified for the
8 pandemic crisis that we are currently in the
9 grips of.

10 We appreciate your attention to
11 these matters and hope to work together in the
12 future to correct systemic issues and establish
13 broad police reforms mandated by the Consent
14 Decree. Please be safe. Thank you.

15 PRESIDENT FOREMAN: Thank you very much.
16 Next speaker, Robert More.

17 MR. MORE: Can you hear me?

18 PRESIDENT FOREMAN: Yes, sir.

19 MR. MORE: Okay. I got two phones here. I
20 got to switch from one to the other here and
21 get my camera on.

22 PRESIDENT FOREMAN: You need to mute one.
23 We have a lot of feedback.

24 MR. MORE: You want me to turn the phones

1 off?

2 PRESIDENT FOREMAN: Put mute on one of
3 them.

4 MR. MORE: Hold on just a second. Turn one
5 of the phones off, right?

6 PRESIDENT FOREMAN: Yes.

7 MR. MORE: Okay. Did we lose you, Mr.
8 More? Mr. More, did we lose you? You may have
9 hung up one of the phones that we have you
10 dialed in on.

11 You know, Mr. More is going to
12 get me next month. I'm going to blame it on
13 Steve Flores.

14 BOARD MEMBER FLORES: Give him a minute.

15 PRESIDENT FOREMAN: Yes. So members of the
16 public, we think we lost Mr. Robert More, so
17 we're going to give him a minute to dial back
18 in. He is our last speaker. Before we adjourn
19 the meeting, we will give Mr. More a moment to
20 call back in. We'd like to make sure all
21 members of the public who would like to speak
22 have the opportunity to speak.

23 MR. MORE: Hello, Mr. Foreman, can you hear
24 me?

1 PRESIDENT FOREMAN: I got you, Mr. More.

2 Wonderful that you were able to dial back.

3 MR. MORE: I have two phones. You can
4 basically hear me, right?

5 PRESIDENT FOREMAN: Yes, sir.

6 MR. MORE: Okay. Very good. First of all,
7 again, Mr. Foreman, you have provided way more
8 value. I have to provide conjectural
9 approbation and so forth because I am concerned
10 not to contribute in the balance of
11 reenforcement of nominal governmental entities
12 in this country because I'm convinced of
13 (inaudible) the legitimacy at this juncture.
14 For reasons the explication, the scope of which
15 is beyond the scope of this conveyance.

16 Here's my issue right now for Mr.
17 Superintendent. What is the present status of
18 the counter-investigation of the Blair-Young
19 (phonetic) murders?

20 PRESIDENT FOREMAN: I'm not sure that the
21 Superintendent is prepared to answer this. You
22 know, if you send us, the Board, something,
23 how -- things related to the Superintendent, so
24 he can look up those things.

1 MR. MORE: I will move on to the next
2 issue, Mr. Foreman.

3 PRESIDENT FOREMAN: Yes, please.

4 MR. MORE: Mr. Superintendent, have you
5 read Jacobson versus Massachusetts and/or Hat
6 (phonetic) versus Solis? These are two Supreme
7 Court cases which are very important in regard
8 to these present circumscriptions on the scope
9 of the liberty provisions that are presently in
10 play. So you are invited to read those and
11 make sure that all the activities are in
12 compliance with them, because there's enormous
13 damage that's being perpetrated on the
14 lock-down subversion of the rule of law via
15 these lock-downs and via quarantining and
16 (inaudible) and encouragement in this area.

17 The next question is, what can I
18 do to get evidence to the state Grand Jury of
19 reckless endangerment in terms of the causation
20 of the COVID-19 and the consequences thereof?
21 Also, is your e-mail address
22 David.Brown@ChicagoPolice.org? Hello?

23 PRESIDENT FOREMAN: Superintendent, he is
24 asking what is a good e-mail address for you,

1 sir?

2 SUPERINTENDENT BROWN: Yeah, don't use
3 David.Brown@ChicagoPoliceDepartment, so we'll
4 use (Inaudible).

5 MR. MORE: Sorry. Please repeat that.

6 SUPERINTENDENT BROWN: (Inaudible.)

7 PRESIDENT FOREMAN: I'll tell you what, Mr.
8 More, why don't you see send Max an e-mail and
9 essentially get it to you because we have a lot
10 of background feedback from your telephone.

11 MR. MORE: I appreciate that. I salute
12 your efforts and your coordination of all this,
13 giving me a second chance to speak after I cut
14 off, Mr. Foreman.

15 PRESIDENT FOREMAN: My pleasure, sir.

16 At this time, all members of the
17 public have now been called. Is there a motion
18 to adjourn?

19 BOARD MEMBER WOLFF: So moved. This is
20 Paula.

21 BOARD MEMBER EADDY: Michael Eaddy.
22 Second.

23 PRESIDENT FOREMAN: All in favor?

24 (CHORUS OF AYES.)

1 PRESIDENT FOREMAN: Motion passes and the
2 meeting is adjourned.

3 Thank you very much, everyone,
4 for your time and your participation. Stay
5 safe. I look forward to seeing you next month,
6 hopefully in person.


