A. ENGLEWOOD NEIGHBORHOOD TIF REDEVELOPMENT PROJECT AREA (WARD 16)

Request authority to advertise the Department of Housing's intention to enter into a negotiated sale with Hope Manor Village Housing, LP for the disposition of the property located at 5922, 5930, 5944, 5950, 6031, 6033, 6035, 6037 and 6050 S. Green Street; 5930, 5932, 5946, 5947, 5958 and 6106 S. Peoria Street; and 6101 S. Sangamon Street in the Englewood Neighborhood Tax Increment Financing Redevelopment Project Area, to request alternative proposals, and to approve the sale of the property to Hope Manor Village Housing, LP if no responsive alternative proposals are received.
