## SUBSTANTIAL COMPLETION CERTIFICATE

**PURSUANT TO** Section 7.01 of the MetraMarket of Chicago, LLC Redevelopment Agreement dated as of August 21, 2008 (the "Agreement") by and among the City of Chicago, an Illinois municipal corporation (the "City"), MetraMarket of Chicago, L.L.C., an Illinois limited liability company ("MetraMarket"), Ogilvie Transit Center Investor, Inc., an Illinois corporation ("OTCI"; jointly and severally with MetraMarket, individually and collectively, the "Developer"), as amended by the First Amendment to Redevelopment Agreement dated as of November 21, 2008 (the "Amendment;" collectively with the Agreement, the "Amended Agreement"), the City, by and through its Department of Community Development hereby certifies as follows:

1. <u>Substantial Completion of Phase 1</u>. The Developer has fulfilled its obligation to substantially complete Phase 1 (as defined in the Amended Agreement) located on the property legally described on <u>Exhibit A</u> hereto, in accordance with the terms of the Amended Agreement.

2. Other provisions of the Amended Agreement; no waiver. Except with respect to the terms of the Amended Agreement specifically related to the Developer's obligation to substantially complete Phase 1, which the City hereby certifies have been satisfied: (a) all executory terms and conditions of the Amended Agreement and all representations and covenants contained therein remain in force and effect; and (b) the issuance of this certificate shall not be construed as a waiver by the City of any of its rights and remedies pursuant to such executory terms.
