- (viii) provided cancelled checks and lien waivers, or the General Contractors' sworn statement and final lien waiver and invoice, for all amounts referenced in subsections (i), (v) and (vii) above;
- (ix) provided proof of its registration of the Ziegler Space for, and progress toward the receiving of, basic LEED certification for corporate interiors; and
- (x) provided proof of having contributed the full amount of the Public Benefits contribution;

all in connection with the rehabilitation of the Ziegler Space located on the property legally described on Exhibit A hereto.

All capitalized terms shown above are defined in the Agreement unless otherwise defined in this Certificate.

All executory terms and conditions of the Agreement and all representations and covenants contained therein remain in force and effect. The issuance of this Certificate of Completion shall not be construed as a waiver by the City of any of its rights and remedies pursuant to such executory terms.
