

Many community members, including volunteers, are reluctant to engage with another housing plan, due to fear that it'll end up being another plan that causes more harm than good, and in the end bring more gentrification to their neighborhoods.

Housing group notes historical pushback from City Council; this is making a divide between city council, city workers and the team members, with the team members emphasizing displacement of residents and prioritization of residents as a whole

The City of Chicago continues to insist that inclusivity will be at the forefront of their planning, but the political walkaround seems to frustrate members consistently. Members of the Honey Pot Performance seem more direct though.

# **Kickoff and Introductions**

- Describe your least successful meeting experience. What about the group dynamics or meeting facilitation made it unpleasant?
  - Linda Young: "One thing that I've been concerned about with a lot of community meetings [is that] we don't seem to have a standard for community engagement and so maybe as we take this journey we can start identifying what those standards should be. I know I've participated in a lot of City of Chicago initiatives, but five people could show up from the community or 550 people show up, and we say 'we've had successful community engagement,' and to me that doesn't seem right."
  - Emma Gonzalez Roberts: "Something that is missing is something about avoiding doing harm with this plan. As we talked about last time, a lot of plans have led to a lot of destruction of livelihoods in the past, and so just being aware of bad outcomes from past citywide plans and just avoiding those as much as possible."

# Overview

- The City of Chicago is currently following the <u>2019-2023 Five-Year Housing Plan</u>, adopted from December 2018 during Rahm Emmanuel's last year.
  - Relevant statistics:
    - 2017 Median sale price value of a single family home: \$203,933 compared to about \$268k in 2020
    - During the plans quarterly report (July '19, about 1 year pre-panini-press) eviction filing rates were 4x's higher in Black neighborhoods
    - Majority of missing rent payments were small amounts: "Over 80% of evictions had a claim for rent and almost two thirds of those cases were for relatively small amounts of money, with 18% for less than \$1,000 and an additional 44% for under \$2,500."
      - Majority of the time tenants are under-resourced in these cases: 79% of landlords had attorneys compared to 11% of tenants.
    - The 2020 census found Illinois to have the second largest loss in population since 2010
      - Chicago was only 0.1% of that loss, but due to the census not having an official deadline, official numbers might not be clear until after 2021
    - <u>361 business closed during the COVID-19 Pandemic</u>
    - Homelessness was already on the rise before the pandemic, according to Block Club Chicago, "In January, even before the pandemic, Chicago's homeless population was already on the rise. The city's Point In Time survey, a citywide effort to count the homeless population on a single night, found 5,390 people living on the streets or in shelters, a 2 percent increase over 2019."
- Historical Reckoning: How are you making sense of historical reckoning? How is historical reckoning connected to your work? How is reckoning connected to our pillar?
  - Jackie Paige: "[Historical reckoning] is why I joined this group. I am a voucher holder, and voucher holders are the largest housing segment in the CHA. Even though they are the largest they're the most marginalized. Their advocacy group is not chosen by them[...] And that's something that I am here to adamantly oppose. The largest housing segment has no voice; their group was disbanded three times [in one year], because the CEO did not like what they were saying, and again they have a group chosen by the CEO."
  - Housing also plans to get involved with the health and safety equity group in order to draft plans that take the impact of neighborhood-level environmental racism into account.



- Linda Young: 28:30-30:15
  - The emotional commitment this is for folks who are not city of chicago workers
  - Team members echo this sentiment in the chat
- Michelle E.L. Merritt says Honey Pot Performance has received feedback from residents who are concerned that yet another housing plan about yet another plan for housing will result in little change and more business opportunities
- There have been around 35 housing plans specifically in the City of Chicago–participants question whether those plans have resulted in benefits for residents
