### RIGHT OF ENTRY APPLICATION FOR ACCESS TO CITY OF CHICAGO PROPERTY

#### Right of Entry (ROE) for Phase I ESA / Survey

A Right of Entry (ROE) permits the applicant to access City-owned real estate. This application is for the specific purposes of accessing City-owned property to conduct a Phase I Environmental Site Assessment and/or Survey of the subject property. It is preferred that the ROE applicant be the party accessing the Property, usually an environmental consultant or surveyor, rather than the prospective purchaser of the property.

#### Process Overview:

- 1) Applicants will submit an Application with ALL Required Documentation in one email to: [2fmrealestate@cityofchicago.org](mailto:2fmrealestate@cityofchicago.org)
- 2) If all Required Documentation is received, Applicants will receive a confirmation email with a tracking number. Incomplete applications will be returned with a request for the missing documentation; a tracking number will not be provided and the application will not be reviewed or placed in queue.
- 3) Applications with tracking numbers will be placed in queue for review by 2FM's and Office of Real Estate Management. Applicants may receive requests for changes to forms submitted in their Application based upon the results of the review.
- 4) After the application passes the review stage, the Application will be sent to the Law Department for drafting the Right of Entry (ROE) Agreement.
- 5) The ROE Agreement will be sent to the Applicant for review and signature. Applicants may scan a signed copy of the ROE Agreement and email it to: [2fmrealestate@cityofchicago.org](mailto:2fmrealestate@cityofchicago.org)
- 6) The ROE will be circulated for signature by the City's Law Department and 2FM Commissioner, and will be issued via email to the Applicant once fully executed. The fully executed ROE will serve as your official permission for access to the Property.
- 7) Applicants accessing the property for a Phase I ESA will be required to submit a copy of the Phase I report to Kimberly Worthington ([Kimberly.Worthington@cityofchicago.org](mailto:Kimberly.Worthington@cityofchicago.org)) from 2FM's EHS Bureau.

## **REQUIRED DOCUMENTATION:**

A complete ROE application must include the following:

1. Applicant Information Form (see page 4)
2. Economic Disclosure Statement
3. Insurance Certificate (see sample on page 5)
4. Scope of Work

## **ECONOMIC DISCLOSURE STATEMENT**

An Economic Disclosure Statement (EDS) must be provided by the Applicant.

**Page 1 line F:** Please write, “Right of Entry agreement for access to City of Chicago Property located at [*Insert Property Address*].”

**Page 1 line G:** Please write, “Dept. of Fleet & Facility Management”

**Contractors:** If a contractor or subcontractor of the Applicant will be accessing the site, the contractor / subcontractor must be listed at the top of page 4 of the EDS (retained parties section) and a certificate of insurance will be required for that party.

**Signature:** The EDS must be signed and notarized within the last 60 days prior to submission.

**Additional EDS:** If the Applicant is a legal entity (eg. Inc., Corp., LLC), the applicant will also be required to provide additional EDSs for any other legal entity owning more than 7.5% of the Applicant or for any legal entity that serves as an officer, director, or manager of the applicant.

**Not for Profits:** If the Applicant is a non-profit corporation, please write “No members are legal entities” at the bottom of page 2 (Officers / Directors section) if none of the members serving on the Board of Directors are legal entities (eg. Inc., Corp., LLC)

**Page 8, Sect. D #2:** Do not check the box in this section. An answer is not required unless the previous question is marked ‘Yes’. Even if the Phase II / Geotech Investigation is in connection with a City property sale, this EDS is not being submitted in connection with the sale but is being submitted in connection with the ROE agreement.

**EDS Appendix B:** Please ensure the EDS you are submitting includes Appendix B, which was added to the EDS form by the City Council in 2015. Many EDS forms do not already include Appendix B and a failure to submit this will result in a delay in processing the application.

## **INSURANCE REQUIREMENTS**

The Applicant must provide a certificate that meets the insurance requirements below. All contractors or subcontractors of the Applicant who will be accessing the site must also provide certificates of insurance. Additionally, any contractor or subcontractor of the Applicant must be listed at the top of page 4 of the Applicant's EDS.

Note: If the following wording appears in the description of operations section of the Insurance Certificate for a contractor or subcontractor, the insurance will be rejected and the application will not be processed any further until proper insurance is provided.

**3) The following coverages and amounts must be provided:**

- (a) Worker's Compensation and Employer's Liability Insurance with limits of not less than \$500,000 for each accident or illness.
- (b) Commercial General Liability Insurance (Primary and Umbrella). Commercial General Liability Insurance, or equivalent, with limits of not less than \$2,000,000 per occurrence (\$5,000,000 for environmental clean-up and remediation work) for bodily injury, personal injury, and Property damage liability. Subcontractors performing work in connection with this Agreement may maintain limits of \$1,000,000 (unless environmental clean-up and remediation is involved, in which case the amount shall remain \$5,000,000).
- (c) Automobile Liability Insurance (Primary and Umbrella) with limits of not less than \$2,000,000 per occurrence for bodily injury and Property damage. The City of Chicago shall be named as an additional insured with respect to such coverage on a primary, non-contributory basis.
- (d) Professional Liability Insurance. When any architects, engineers, construction managers or other professional consultants perform work in connection with this Agreement, such parties shall procure and maintain Professional Liability Insurance covering acts, errors, or omissions with limits of not less than \$1,000,000, with coverage including contractual liability.
