**Response to Consulting Party Comments – June 15, 2023**

The Chicago Department of Assets, Information and Services (AIS) contacted potentially interested members of the public, organizations, and tribes on April 12-13, 2023 to request participation as a consulting party and to solicit comments to the proposed undertaking. AIS included a letter and attachments, which described the project, discussed the Illinois State Historic Preservation Office (SHPO) determination of an adverse effect, provided the proposed Area of Potential Effect (APE), detailed a proposed mitigation strategy, and included a web address for additional information. AIS established a 30-day comment period which ended on May 15, 2023. Comments and questions from the consulting parties are presented below in order of receipt. This document has been developed to meet documentation requirements under 36 CFR 800.4 and is intended to provide a response to the comments received.

### **Consulting Party Comments Received**

1. **Consulting Party:** Illinois State Historic Preservation Office (SHPO)

**Date:** April 18, 2023

**Summary of Comments:** Illinois SHPO acknowledged receipt of the April 12 AIS notification. No further comments received.

**Response:** No additional response required at this time.

2. **Consulting Party:** Forest County Potawatomi Community of Wisconsin (FCPC)

**Date:** April 24, 2023

**Comments:** “The Tribal Historic Preservation Office (THPO) staff has reviewed the information you provided for this project. Upon review of site data and supplemental cultural history within our Office, the FCPC THPO is pleased to offer a finding of No Historic Properties affected of significance to the FCPC, however, we request to remain as a consulting party for this project.

As a standard caveat sent with each proposed project reviewed by the FCPC THPO, the following applies. In the event an Inadvertent Discovery (ID) occurs at any phase of a project or undertaking as defined, and human remains or archaeologically significant materials are exposed as a result of project activities, work should cease immediately. The Tribe(s) must be included with the SHPO in any consultation regarding treatment and disposition of an ID find.”

**Response:** AIS replied to the FCPC on April 25, 2023 to acknowledge their request for consulting party status and concurred with the process described in the event of an Inadvertent Discovery.

3. **Consulting Party:** Advisory Council on Historic Preservation (ACHP)

**Date:** May 2, 2023

**Summary of Comments:** AIS received a letter from ACHP indicating they are unable to determine whether Appendix A, *Criteria for Council Involvement in Reviewing Individual Section 106 Cases*, applies to this undertaking. ACHP requested that AIS submit copies or summaries of any views provided by consulting parties, federally recognized Indian tribes, and the public so that ACHP can determine whether their participation in consultation to resolve adverse effects is warranted.

**Response:** This Response to Consulting Party Comments document and subsequent AIS submission of an updated e106 form to ACHP will serve as an AIS response.
