## NOTICE OF JOB OPPORTUNITY VOLUNTEER – UNPAID

## Lead Poisoning Prevention and Healthy Homes Program

**DESCRIPTION:** The Chicago Department of Public Health (CDPH) promotes and improves health by engaging residents, communities and partners in establishing and implementing policies and services that prioritize residents and communities with the greatest need. At CDPH, diversity is one of our core values. Individuals from diverse racial and ethnic backgrounds as well as those of all sexual orientations and gender identities are encouraged to apply.

The Division of Environmental Health, Lead Poisoning Prevention and Healthy Homes Program (LPPHHP) is seeking volunteers with an interest in environmental science or health. The mission of LPPHHP is to detect and address exposures to lead hazards. Strategies include inspections and abatement, public education campaigns, and testing. CDPH is leading efforts to permanently eliminate lead exposure to children.

**DUTIES:** LPPHHP is seeking students to work as unpaid interns, assisting with various duties as assigned depending on the program. Applicants will need strong written and oral communication skills. Ability to work on a fast-paced office environment, managing multiple shifting priorities, self-motivated, creativity and positive attitude are a must. Assigned duties are specific to current operational needs, but potential duties may include:

- Conducting literature reviews or other research-related efforts and incorporating findings into reports; research policy best practices and implications in other state and local governments;
- Reviewing current policies and procedures and update as necessary; develop workflow analysis for the various programs;
- Performing functions to support offsite events, including festivals, health fairs, in-school programming, and other events, including preparing for and attending such events;
- Attending internal meetings;
- Representing the department through meetings with external entities;
- Assisting in the design and marketing of program materials and assets for social media, web, and e-communications;

- Performing various administrative functions to support program activities and projects;
- Opportunities may also be available to accompany field staff.
- Performing related duties as required.

**NOTE:** A writing sample will be required at time of application. This is a temporary, unpaid position. Hours will vary based on academic and program requirements

**RESIDENCY REQUIREMENT:** City of Chicago residency is not required.

SALARY: UNPAID

**CLOSING DATE:** Open until further notice.

**EDUCATIONAL REQUIREMENTS:** Enrollment in a Bachelor's Degree program or higher at an accredited college or university. Preference will be given for individuals enrolled in a public health or medical program, or related field.
