We are looking for an intern who can assist our section with promoting our work, reports, and events. This intern will gain valuable hands-on experience working for the City of Chicago. **Note: This is an unpaid internship.**

DUTIES

- Assist with the research and development of marketing and event programming
- Post and monitor social media, to include monthly campaigns and analytics
- Staff/attend community outreach and engagement events
- Perform clerical activities and update databases, when needed
- Attend departmental and editorial meetings, as requested
- Support special projects, when requested
- Flexibility to travel with outreach team throughout Chicago

MINIMUM OUALIFICATIONS

- Currently enrolled in an accredited college or university as a senior or graduate student, pursuing an undergraduate or graduate degree in Communications, Journalism, Public Policy, or other related fields
- Students must have a minimum cumulative grade point average of 3.0 on a 4.0 grading scale or a 4.0 on a 5.0 grading scale; and must maintain the required GPA throughout the duration of their employment/internship.
- Strong written and verbal communication skills
- Solid understanding social media networks and analytics
- Ability to multitask and meet deadlines
- Ability to be both creative and analytical when approaching a task
- Proficiency in word processing, database work, e-mail, and internet research
- Knowledge of Microsoft Office, Adobe Applications, social media platforms, and graphic design

PREFERRED QUALIFICATIONS

- Strong attention to detail and experience with drafting content and editing
- Experience interacting with persons of various social, cultural, economic, and educational backgrounds, with a demonstrated awareness and sensitivity to the needs and concerns of individuals from diverse backgrounds and orientations

- A commitment to excellence as evidenced by academic honors, academic and social awards, extracurricular activities and involvement in community or public service

- 5. Attach your transcript; and
- 6. Attach your writing sample.

NOTE: To be considered for this position you must provide all the information listed above. If you fail to provide this information at the time you submit your application, your submission will be incomplete, and you will not be considered for an interview. Application materials will only be accepted by e-mail at jobs@igchicago.org. If there is more than one open position in which you are interested, you may apply for more than one title by submitting an individual e-mail for each title. Repeat instruction steps one through six with each e-mail.
