OVERALL GOAL for FAA-ASSISTED CONTRACTS
Midway Airport

FISCAL YEAR 2017, 2018, AND 2019

I. INTRODUCTION

The City of Chicago (City) submits its Disadvantaged Business Enterprise (DBE) overall goal for Midway Airport to the Federal Aviation Administration (FAA) for review and approval. The report has been prepared to comply with the DBE Federal Regulations, 49 CFR Part 26, and describes the methodology used to establish the City's overall FAA DBE goal for FFY 2017-2019. The City performed a thorough analysis of the relative availability of DBEs to participate in our DOT-assisted contracts by using historical contract and payment data, the IL UCP Directory of Certified DBEs, and the Census Bureau's County Business Pattern database to arrive at its overall goal of 26 percent.

II. PROPOSED OVERALL GOAL FOR FAA-ASSISTED PROJECTS, FFY 2017-2019

The recommended overall DBE goal for FFY 2017-2019 will be 26 percent. The total FAA-assisted contract amounts the City of Chicago expects to bid out in the next three years is as follows:

III. METHODOLOGY USED FOR DETERMINING DBE OVERALL GOAL

In order to establish an overall goal consistent with the process in 49 CFR Part 26, the City began by defining its local market for FAA-assisted contracts by collecting and analyzing data from the IL UCP Directory of Certified DBEs, bidder's list and U.S. Census data. The City's Uniform Report of DBE awards, commitments and payment reports were also used in determining the City's overall DBE goal.

Based on available data from the City's FAA-assisted contracts, the City determined that virtually all DBEs performed (either as prime contractors or subcontractors) in the following North American Industry Classification System (NAICS) Codes:

IV. BASE FIGURE DETERMINATION

To determine a base figure of relative availability of DBEs, the City used County Business Pattern data available for the Local Market and the IL UCP Directory of Certified DBEs. A six-digit NAICS code was assigned to each of the anticipated federally funded projects in FFY 2017-2019. Table 1 below defines the NAICS codes by Industry:

1. Relative Base Figure

The USDOT rules require the calculation of the base figure using the following formula:

$$\text{Step One Base Figure} = \frac{\text{Ready, willing and able DBEs}}{\text{All ready, willing and able businesses (Including DBEs and non-DBEs)}}$$

Using this calculation, Table 2 below represents the relative DBE availability by NAICS code of the anticipated contracts only. The percent of available businesses in each NAICS code reflects the portion of all available businesses within Cook County. The relative availability of DBEs is 15.03 percent.

2. Weighted Base Figure

For each industry in which the City anticipates to award, the City used the number of listed DBEs as the numerator and the total number of all established businesses as the denominator and then weighted these percentages based on the percentage of the estimated budget for FFY 2017-2019. Table 3 represents the calculation of weighted availability, which was determined to be 21.73 percent for DBEs.

V. STEP TWO ADJUSTMENT FACTOR

The Step Two base figure adjustment, as recommended in Tips for Goal Setting, requires examining relevant and reliable data in the recipient's market area to determine if an adjustment to the base figure is warranted. The consideration of an adjustment is intended to account for any impact the relevant factors may have on a DBE's contracting opportunities with the City of Chicago.

After calculating a base figure of the relative availability of DBEs, evidence was examined to determine what adjustment (if any) was needed to the base figure in order to arrive at the overall goal. The data used to determine the adjustment to the base figure was the median of historical DBE participation which range from 30.53% to 100% (see chart below).

The median past participation for these years is 30.60%. The difference between the Step One weighted base figure (21.73%) and the median past DBE participation (30.60%) indicates that DBEs have the capacity to perform Aviation work and suggests that an adjustment of the Step One base figure is warranted. By calculating the average of the Step One weighted base figure and the average median of past participation, the City of Chicago determined an adjusted base figure of 26.16% or 26%. This is an overall goal for the Midway Airport.

VI. Breakout of Estimated Race-Neutral and Race-Conscious Participation

The City of Chicago will meet the maximum feasible portion of its overall goal by using race-neutral means to facilitate DBE participation. The City of Chicago uses the following race-neutral means to increase DBE participation: 1) Provide assistance in overcoming limitations such as the inability to obtain bonding or financing; providing technical assistance in the workplace; 2) Convey information and communications on specific contracting procedures and contract opportunities; 3) Update the distribution of the DBE directory through print, if necessary, and electronic means to the widest feasible universe of potential prime contractors; 4) Assist DBEs, and other small businesses to develop their capacity to utilize emerging technology and conduct business through electronic media; and 5) Break out large projects into small bid packages.

The City is also prepared to implement or re-establish the following contractor development initiatives as a means to increase race neutral participation: 1) Provide services to help DBEs, and other small businesses, improve long-term development, increase opportunities to participate in a variety of kinds of work, handle increasingly significant projects, and achieve eventual self-

sufficiency; 2) establish a program to assist new, startup firms, particularly in fields in which DBE participation has historically been low; 3) review solicitations and specifications for ways to unbundle and divide work among lower capacity contractors; 4) encourage DBEs to network within their specialty for joint venture opportunities; and 5) educate larger prime contractors and DBEs on the policies and procedures of Mentor-Protégé programs and encourage them to form Mentor-Protégé relationships.

We estimate that in meeting the FAA goal of 26 percent we will obtain 2 percent from race-neutral participation and 24 percent through race-conscious measures. This estimate has been based on past participation in which the bulk of our race neutral participation has been gained through exceeding contract goals, rather than the expected DBE prime contractor participation.

The City anticipates increased race neutral participation as the result of our continually evolving outreach programs (See Attachment A – needs to be updated) project awareness forums, new business development initiatives like, capacity building and prompt pay contract requirements.

We will adjust the estimated breakout of race-neutral and race-conscious participation as needed to reflect actual DBE participation and will track and report race-neutral and race-conscious participation separately. For reporting purposes, race-neutral DBE participation includes, but is not necessarily limited to the following: DBE participation through a prime contract that a DBE obtains through customary competitive procurement procedures; DBE participation through a subcontract on a prime contract that does not carry a DBE goal; DBE participation on a prime contract that exceeds the contract goal; and DBE participation from a subcontract through a prime contractor that did not consider a firm's DBE status in making the award.

VII. Contract Goals

The City of Chicago will use contract goals to meet any portion of the overall goal that the City of Chicago does not project being able to meet using race-neutral means. Contract goals are established so that, over the period to which the overall goal applies, they will cumulatively result in meeting any portion of our overall goal that is not projected to be met through the use of race-neutral means.

We will establish contract goals only on those FAA-assisted contracts that have subcontracting possibilities. We need not establish a contract goal on every such contract, and the size of contract goals will be adapted to the circumstances of each such contract (e.g., type and location of work, availability of DBEs to perform the particular type of work). We will express our contract goals as a percentage of the total amount of DOT-assisted contracts.

VIII. Good Faith Efforts

The City of Chicago handles bidder's/respondent's compliance with good faith efforts requirements as a matter of responsiveness. Each solicitation for which a contract goal has been established will require the bidder/respondent to submit the following at the time of bid submission:

- a. Names and addresses of DBE firms that were solicited for potential DBE and non-DBE participation as a subcontractor.
- b. Written and signed documentation of commitment to use a DBE subcontractor whose participation it submits in order to meet a contract goal.
- c. A description of the work that each DBE will perform.
- d. Dollar amount of participation of each DBE firm performing work.
- e. Written and signed confirmation from the DBE that it is participating in the contract as provided in the prime contractors commitment.
- f. If a commitment to the contract goal could not be met, evidence of good faith efforts must be fully documented and submitted to the City for review and approval.

IX. Process and Notice of Goal

Before establishing the overall goal, the City of Chicago will consult with minority and woman contractors and groups, local assist agencies, prime contractors, and certified vendors to obtain information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBE's and the City of Chicago's efforts to establish a level playing field for the participation of DBE's.

A notice of the proposed overall goal will be published, informing the public that the proposed goal and its rationale are available for inspection during normal business hours for 30 days following the date of the notice. Our overall goal submission to DOT will include a summary of information and comments received during this public participation process and our responses.

Attachment A

In January 2014, under the leadership of Mayor Rahm Emanuel, the City of Chicago Department of Procurement Services (DPS) initiated a series of meetings with the City's sister agencies and invited County, State and Federal government as well as the Affirmative Action Advisory Board and non-profit assist agencies representing the vendor community. These meetings grew into the Government Procurement Compliance (GPC) Forum, a strategic planning effort, which entails the formation of a number of working subcommittees tasked with researching and reviewing best practices and recommending solutions to shared challenges in order to take steps to improve opportunities and services for small businesses. Key accomplishments include the Consolidated Buying Plan (4 editions to date), and the 2016 Vendor Fair that included 100+ exhibitors providing opportunity information to small businesses.
