ARTICLE 5. SCOPE OF WORK AND DETAILED SPECIFICATIONS

- 1.) Section 5.4. General is hereby deleted in its entirety and replaced with the following:**

5.4. General

The Contractor will provide all trucks, personnel, labor, transport, permits, insurance, bonding, licenses, equipment and expert services required to legally transport dispose of Sewer Debris (Special Waste), Catch Basin Debris (Special Waste) and General Construction Debris (Non-Special Waste) received from the Department of Water Management's transfer station.

The Contractor will be required to procure contractual access, sufficient to cover the term of the Contract, to one or more disposal sites for the disposal of sewer and catch basin debris.

Water Management will load the sewer or catch basin debris onto the Contractors trucks for transport to approved disposal sites.

The City will notify the Contractor within 24 to 48 hours, Monday through Friday of the day prior to the requested pick-up. The order will be placed via email, phone or fax. At the time of placing the order, the City will specify the number of trucks needed and or estimated tonnage to be removed.

The City reserves the right to cancel an order two (2) hours prior to the scheduled pickup time.

The City reserves the right to change the waste-pick-up location from 3901 S. Ashland to another location. The City also reserves the right to add more waste- pick-up locations. Any additional costs arising directly or indirectly from a change of waste pick-up location or the addition of more waste-pick-up locations will be borne solely by the Contractor.

A. Sewer Debris (Special Waste) (Bid Line 1)

The Contractor will furnish the Hauling of Sewer Debris from City of Chicago transfer station to the Contractor's disposal sites.

The Contractor must identify the location of the disposal site by completing, Article 10, Bidder Contact Information of the Specification.

The price per ton of Sewer Debris will be listed on Line 1 on the proposal page which will include the current inclusive costs (federal, state and local taxes and fees), if applicable.

B. Catch Basin Debris (Special Waste) (Bid Line 2)

The Contractor will furnish the Hauling of Catch Basin Debris from City of Chicago transfer station to the Contractors disposal sites.

The Contractor must identify the location of the disposal site by completing, Article 10, Bidder Contact Information of the Specification.

The price per ton of Catch Basin Debris will be listed on Line 2 on the proposal page which will include the current inclusive costs (federal, state and local taxes and fees), if applicable.

C. General Construction Debris (Non-Special Waste) (Bid Line 3)

The Contractor will furnish the Hauling of General Construction Debris from City of Chicago transfer station to the Contractors disposal sites.

The Contractor must identify, the location of the disposal site by completing, Article 10, Bidder Contact Information of the Specification.

The price per ton of General Construction Debris will be listed on Line 3 on the proposal page which will include the current inclusive costs (federal, state and local taxes and fees), if applicable.

The Department of Water Management will load the Sewer Debris (Special Waste), Catch Basin Debris (Special Waste) and General Construction Debris (Non-Special Waste) on the Contractor's trucks for hauling to a disposal site. The price per ton price will include all peripheral costs (e.g. soil testing, processing, transport, labor, materials, equipment, taxes, fees, permits, bonding, insurance, licenses, etc.), as quoted on the Proposal Page(s).

Upon receipt by the Contractor, the debris will become the property of the contractor for disposal.

- 2.) Section 5.6. Product Removal is hereby deleted in its entirety and replaced with the following:

5.6 Product Removal

The Sewer Debris (Special Waste) or Catch Basin Debris (Special Waste) which will be removed and hauled by vendor from the City's transfer station may include organic and inorganic materials along with dirt, sand gravel and may include other materials typically accumulated in sewers not limited to grease, plastic bags, diapers, human waste, towels (black water, human waste), and included in catch basins, not limited to oil, fuel antifreeze, plastic bottles, leaves, hypodermic needles, food wrappers (grey water, non- human waste), pieces of brick, concrete, lumber, etc.

The General Construction Debris (Non-Special Waste) Debris to be removed and hauled by vendor from the City's transfer station may include organic and inorganic materials along with dirt, sand gravel and may include construction debris limited to concrete, stone and dirt. (Note no other objects can be in the debris such as wood, construction materials anything other than concrete, stone and dirt taken from sites.

The Contractor will haul and/or transfer debris in vehicles and/or containers complying with all applicable Federal, State, City and other local governmental and agency's laws, ordinances, rules, regulations and codes as described herein "Environmental Control During Transport" as specified in **Section 3.3.11. Compliance with Environmental Laws and Related Matters**. All equipment used to haul debris will be designed to prevent the blowing, dripping and spillage of debris during the hauling operation. Contractor's equipment must fully comply with all City, State and Federal regulations, laws and ordinances pertaining to size, load weight and safety. The City will not be liable for any violation committed on the part of the Contractor in the handling, hauling, disposal or transportation (by any method) of debris.

The Contractor must comply with all applicable Federal, State, City and other local governmental and agency's laws, ordinances, rules, regulations and codes, including but not limited to the Resource Conservation and Recovery Act, the Comprehensive Environmental Response, Compensation and Liability Act, The Department of Transportation Regulations, the Hazardous Materials Transportation Act, the Clean Air Act, and the Clean Water Act, the Illinois Environmental Protection Act, the Municipal Code of the City of Chicago, currently in effect and as amended during the course of this contract period.

Soil characterization must be performed by the Contractor in conformance with standards set forth by the Illinois Environmental Protection Agency (IEPA) 35 Illinois Administrative Code (IAC) 742, "Tiered Approach to Corrective Action Objectives (TACO)", United States Environmental Protection Agency (USEPA) SW-846, "Test Methods for Evaluating Solid Waste, Physical/Chemical Methods", ASTM E1903-97 standard, "Standard for Environmental Site Assessments: Phase II Environmental Site Assessment Process", Occupational Health & Safety Administration (OSHA) 1910 and 1926 Standards and 35 IAC 1100, "Clean Construction or Demolition Debris Fill Operations (CCDD)" at no additional cost to the City. Vendor must perform soil boring and laboratory testing of the debris to determine if debris generated from City of Chicago activities and taken to fill operations is "Uncontaminated" as defined in the above referenced standards and debris will be accepted at a Clean Construction and Demolition Debris operation (CCDD) and provide an EPA form #663 signed by a Professional Engineer (P.E) or Professional Geologist (P.G.) licensed in the State of Illinois. All testing must be included in the price per ton and be provided at no additional cost to the City.

The cost to provide all necessary forms and permits to dispose of waste a CCDD will be responsibility of the Contractor.

The Contractor will provide the analysis and copies of the reports after each pick-up, etc. to

the Department of Water Management, 1000 East Ohio Street, Chicago, IL 60611, and Attention to the Commissioner.

SECTION II: QUESTIONS SUBMITTED FOR CLARIFICATION

- 1.) Question: Will the cost of providing laboratory testing be the responsibility of the City or of the vendor?

Answer: See Revision No. 2 of this Addendum No. 7.

- 2.) Question: Does this contract (Specification no. 396370) include a bid line for testing services?

Answer: No. This project does not include a bid line for testing services.

- 3.) Question: What City of Chicago Department is the generator of all Sewer Debris, Catch Basin Debris and General Construction Debris.

Answer: (See Section 5.4. General) the City of Chicago, Department of Water Management is the generator of all Sewer Debris, Catch Basin Debris and General Construction Debris and will have the materials separated in their respective bins for hauling.

- 4.) Question: Will the current contract be extended by the City of Chicago?

Answer: No. The preference of the City is not to extend the current contract.
