SECTION I: Questions Submitted for Clarification of the Bid Specification

Question 1: Ford has pulled forward the final order date for 2019 Model Year F-150s with the V8 engine to June 19, 2019. The final date order date for all 2019 Model Year pickup trucks from Ford is August 2, 2019. This means if bids are due June 14th, 2019 the pricing would be invalid within 60 days. Ford anticipates a price increase for the 2020 Model Year. Please let me know how we should address this within the bid response.

Answer 1: Bidders need to submit a price that they can honor for the first 12 months of the contract. Refer to Section 6.8.1 Price Adjustments Group A: Bid Lines 1 thru 18, Group B: Bid Lines 23 thru 26; Group C: Bid Lines 31 thru 38 in the original solicitation for details.
